#### **DESCRIPTION**

10-12 Cave Street forms part of a terrace of Grade II listed Georgian buildings which provide office accommodation over basement, ground and 3 upper floors. The buildings currently offer interlinked accommodation serviced by a ground floor reception area but could be sub-divided into 2 separate buildings, or internally on a floor by floor basis.

There is a kitchen located with direct access from the ground floor reception area. The upper floors are primarily open plan office space and there are 3 off street car parking spaces and a small courtyard garden to the rear of the properties.


