



### LOCATION

Generator Studios is located on Trafalgar Street in Newcastle City Centre and enjoys a very prominent position between the Quayside and Grainger town.

The location benefits from excellent access to Newcastle Central Motorway (A167) and Manors Metro Station is located 300m away. Newcastle Central Station is only a five minute walk.

#### DESCRIPTION

Generator Studios is a contemporary designed multi let office building with dedicated car parking.

The accommodation is accessed via a double-door entrance with a dedicated staff reception providing access to bookable boardroom and communal meeting room facilities together with a coffee shop, shower rooms, male and female toilets and a passenger lift.

The lower ground suite provides open plan space with a floor to ceiling height of 3m solid concrete floor and LED lighting. The studio will be refurbished to the following standard:-

- New wood flooring throughout
- New tea point
- External decking to dedicated break out space
- Full redecoration throughout
