## Description

This property comprises good quality traditional warehousing accommodation which is available on a standard property leasing basis or as a managed contract by the Fife Group.

The warehousing is arranged as three separate buildings which could be made available separately or in combination.

Ample yard space surrounds the buildings and the eaves height in Buildings 1 and 2 is 8m rising to the apex of 12m. Buildings 3 and 4 have an eaves height of 6.7m rising to the apex at 12.8m.

The vehicle access doors are electrically operated and supporting office accommodation and wash bay facilities can be provided on site if required by the new tenant There is a good sized area available with these buildings.


