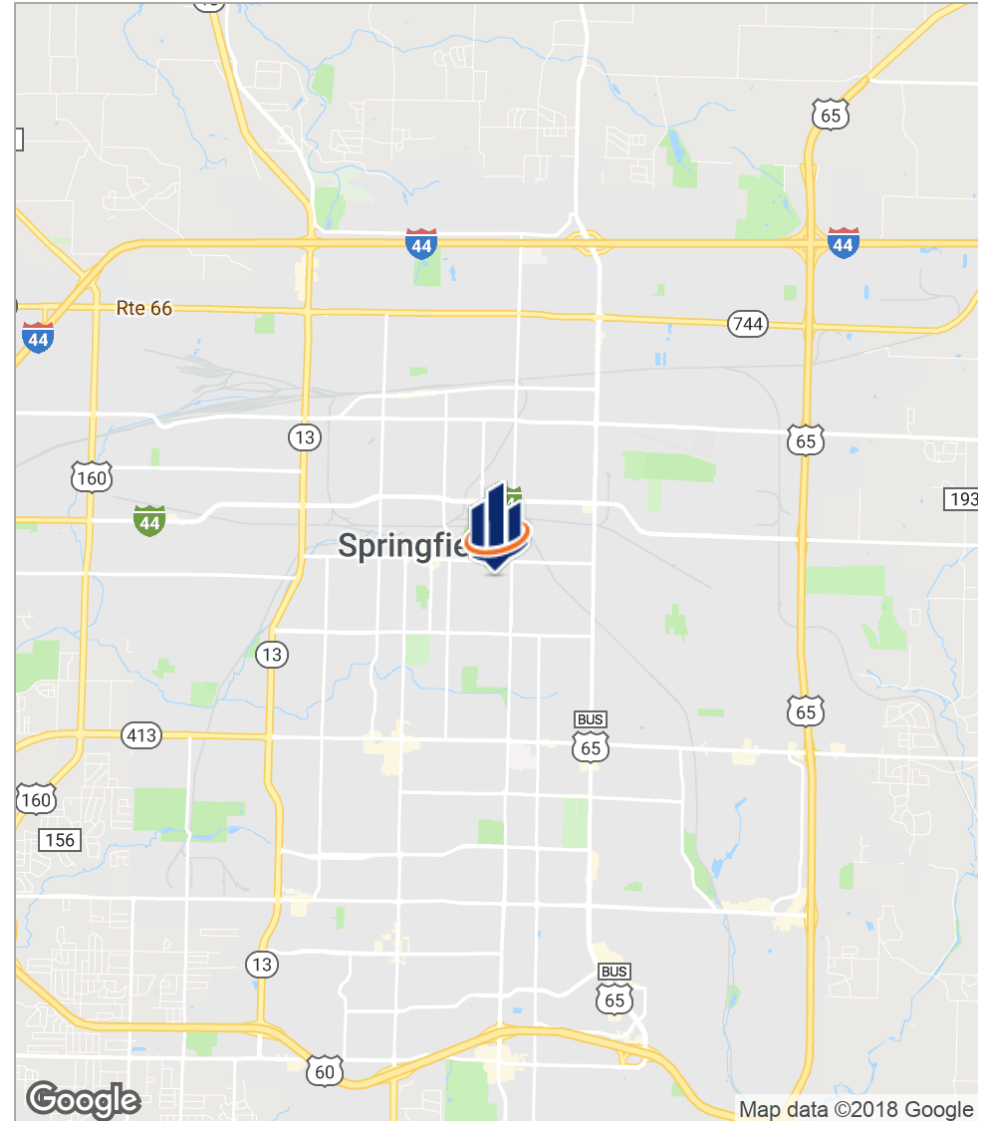
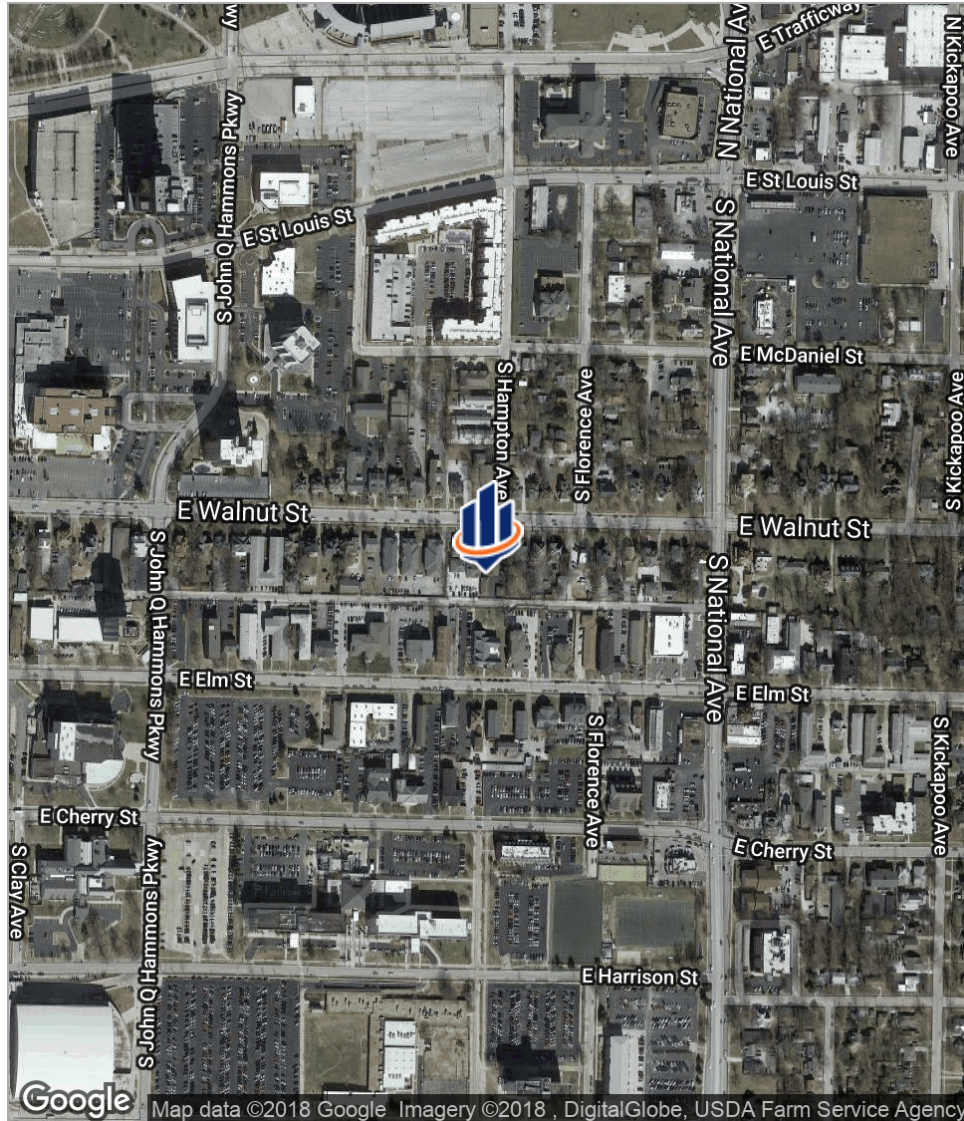

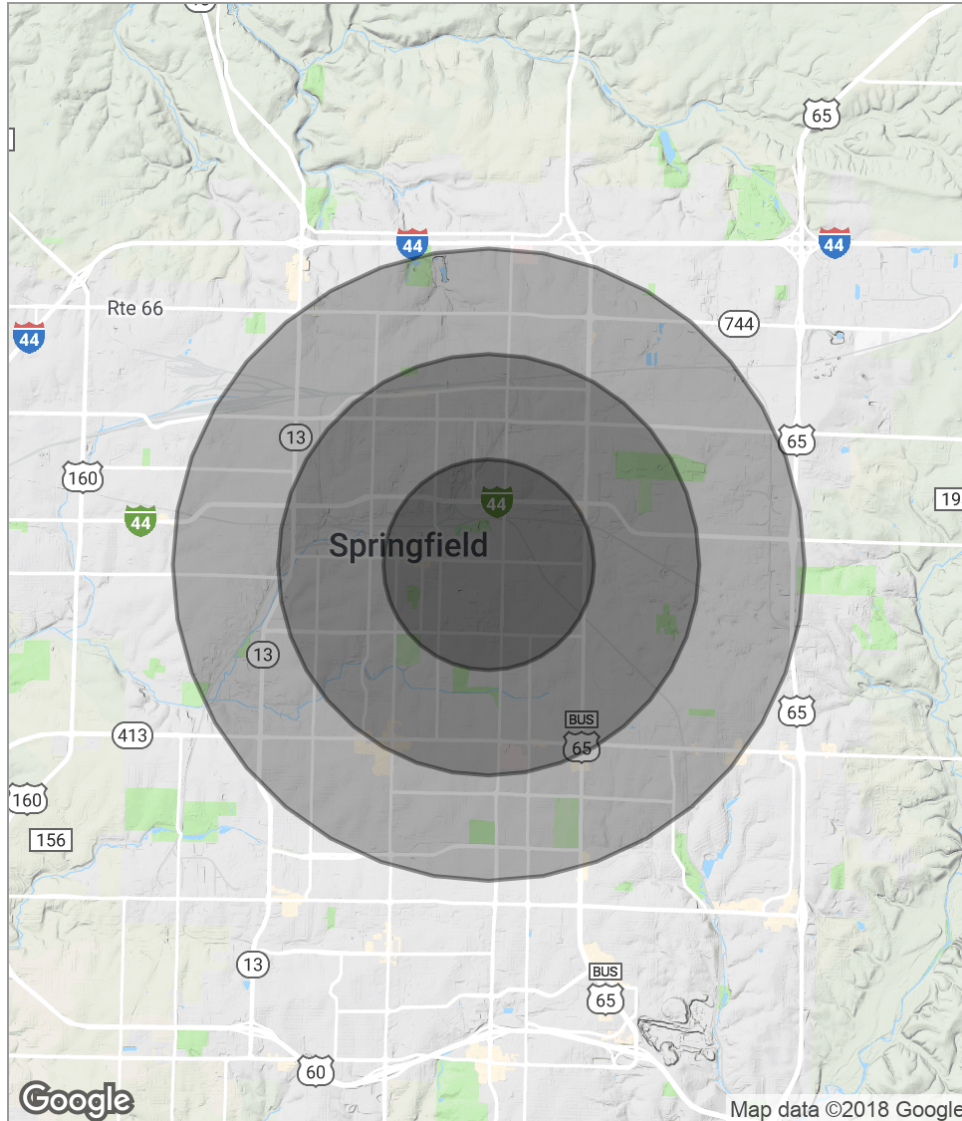
Retailer Map
