## **LOCATION**

The premises are located on Magdalen Road which runs between Iffley Road and Cowley Road on the eastern side of Oxford ¾ mile form The Plain Roundabout at St Clement's.

Cowley Road is a vibrant mixed-use road with a high student population and a large variety of retail and leisure facilities.

Magdalen Road also accommodates a variety of uses including small start up business units, residential properties, specialist retail and coffee shops.

#### **DESCRIPTION**

The premises offer versatile accommodation which is currently used as mixed office and stores. There is off street car parking for 6 cars plus some display frontage and access directly onto Magdalen Road. The workshops/stores have their own separate access to the right hand side.

The offices benefit from air conditioning units with heating supplied by gas fired hot waster fed radiators. Lighting is mainly fluorescent tube.

There is a kitchen and reception area included in the ground floor areas below.
