## LOCATION

Bowburn South Industrial Estate is prominently located just off the A1(M), being circa 0.6 miles from Junction 61 offering excellent communication links to the regional and national road networks.

Occupiers on the Estate include County Durham and Darlington Fire and Rescue Service, Fleet Factors, Walker Snacks and Hall Construction.

Local services and amenities are provided a short distance away within Bowburn.

## DESCRIPTION

The property comprises a selection of terraced industrial units with open yard / car parking to the front.

Internally the property offers an open plan workshop / warehouse with separate single storey offices.

The unit has an effective eaves height of 5.9m (Apex 6.6m).

Vehicular access to the property is via a selection of steel security automatic roller shutters.

The offices are fitted to a basic standard offering cellular accommodation, reception and WC facilities with UPVC double glazing, surface mounted lighting and carpet to floors.

Externally there is dedicated open parking / forecourt with landscaped area.

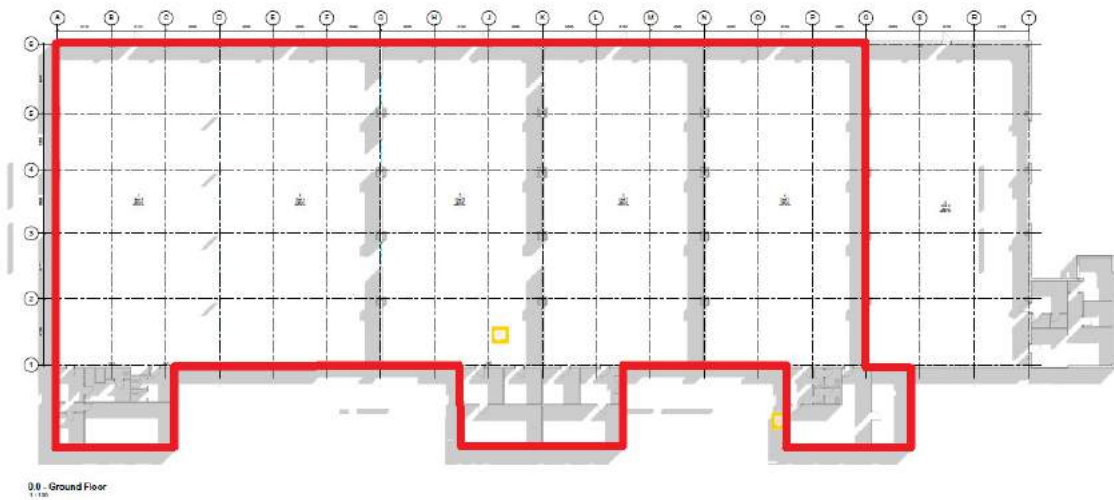
