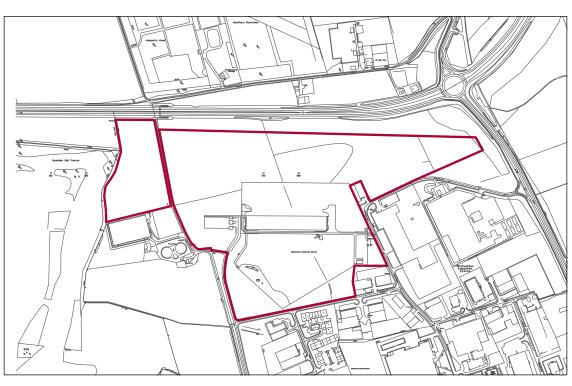
Site

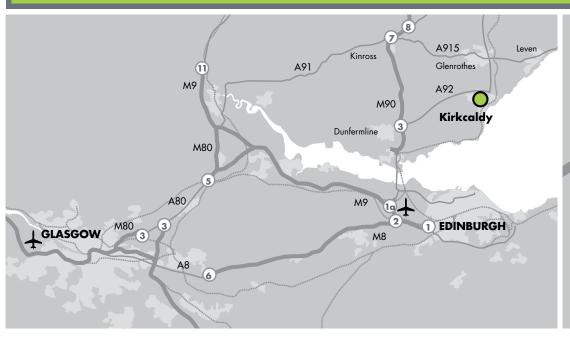

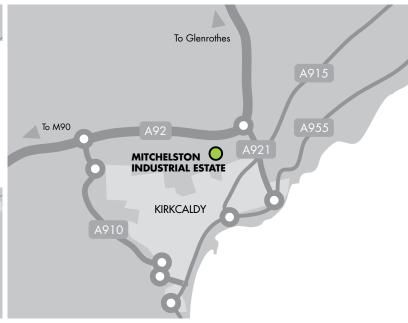
