LOCATION

Stretford Mall Shopping Centre is the principle shopping destination in the town and A56 corridor of south Manchester. The scheme provides over 340,000 sq ft of covered retail accommodation. The scheme benefits from an immediate catchment of 44,000 (Census 2001) with the most recent annual footfall of approximately 6.7m visitors per year (Experian 2009).

The scheme is anchored by **Tesco**, **Wilkinson and Peacocks**, with other major retailers including **Iceland**, **Boots**, **WH Smiths** and **Argos**.

The subject premises are situated in a strong location within the scheme on Chester Street Mall, opposite the Market Hall. Neighbouring retailers include TJ Hughes, Poundland, Textiles Direct and Specsavers.

The property is arranged on ground floor and first floor with servicing to the rear.

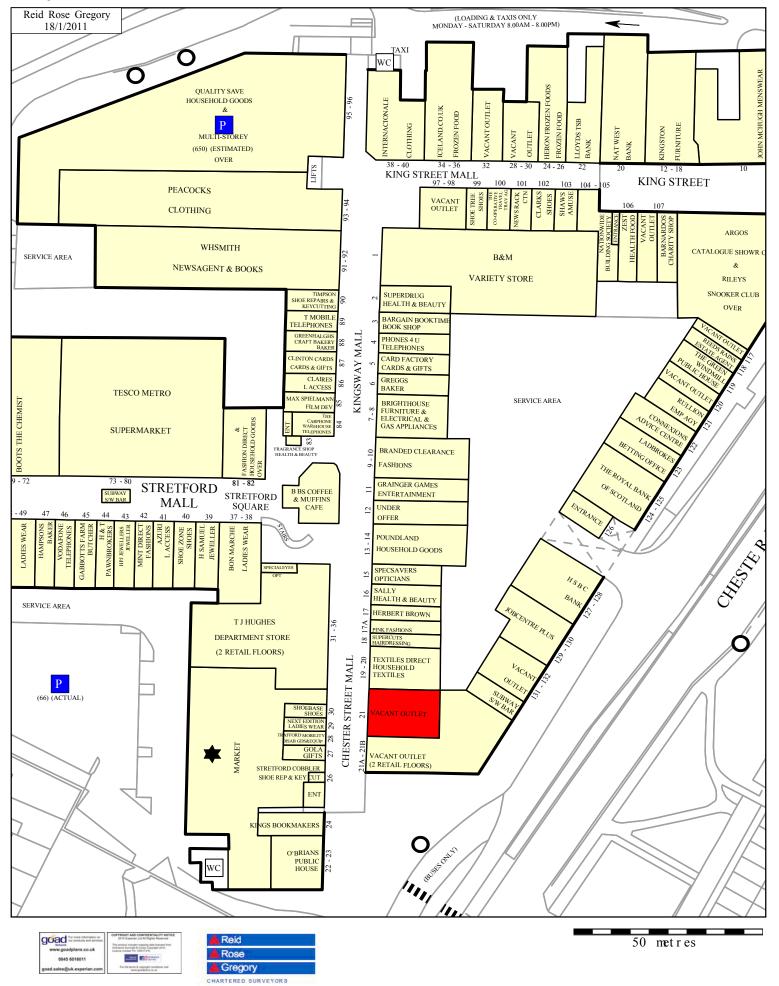
