Location

The Winterhill business and retail park is approximately 1 mile to the South of Central Milton Keynes and approximately 3 miles to the West of Junction 14 of the M1 motorway. Winterhill is accessed from two of the main urban "grid roads" V6 Grafton Street and H6 Childs Way. Major occupiers in Winterhill include Honda, Mugen, Big Yellow Self Storage, Pure Gym and Franklite.

Description

Snowdon House is a detached office building with accommodation over three floors. The office floorspace is fitted with central heating, comfort cooling, suspended ceilings, underfloor trunking with electrical sockets and data points (not tested). There is an excellent level of natural daylight from double glazed windows on three elevations.

There is a glazed ground floor reception area, lift access to the upper floors and an access control system for the building. The private grounds have approximately 52 car parking spaces.


