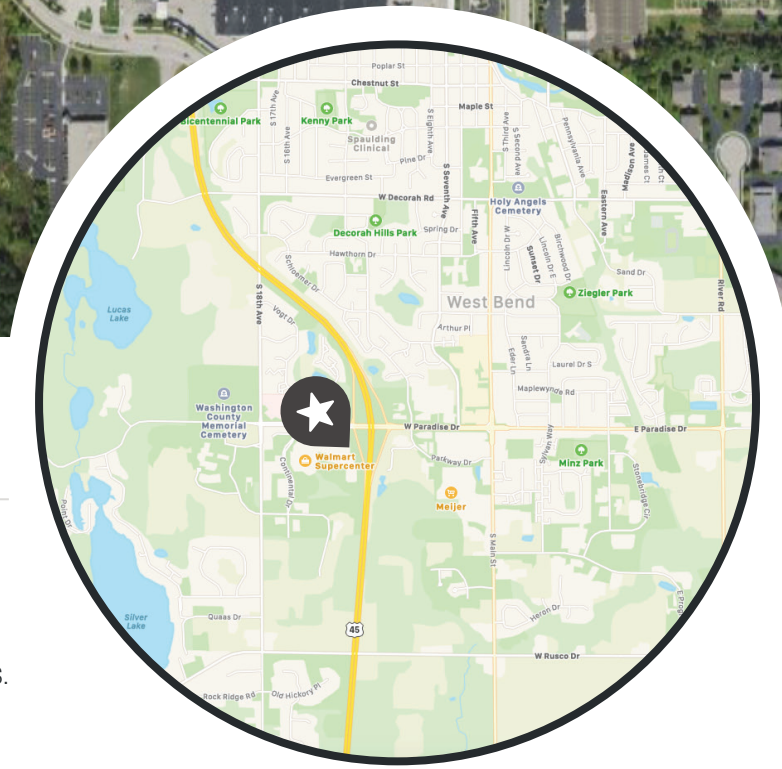

- 12 ▪ The duty to protect your confidentiality. Unless the law requires it, the broker will not disclose your confidential information or
13 the confidential information of other parties (See Lines 22-39).
- 14 ▪ The duty to safeguard trust funds and other property the broker holds.
- 15 ▪ The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and
16 disadvantages of the proposals.
