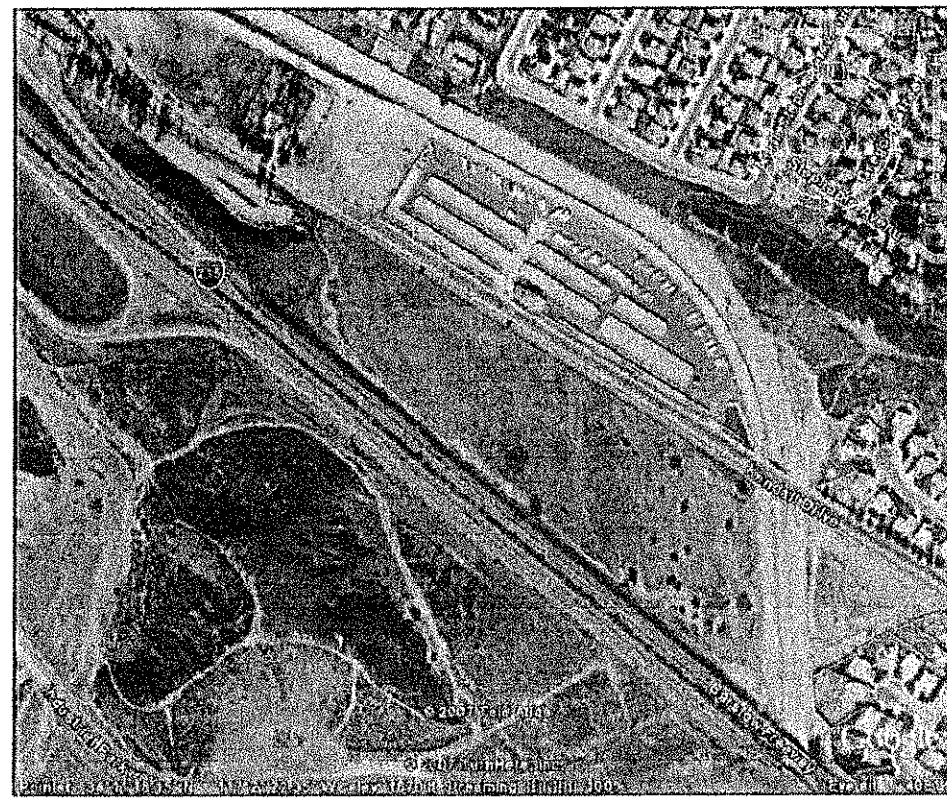
VICINITY MAP

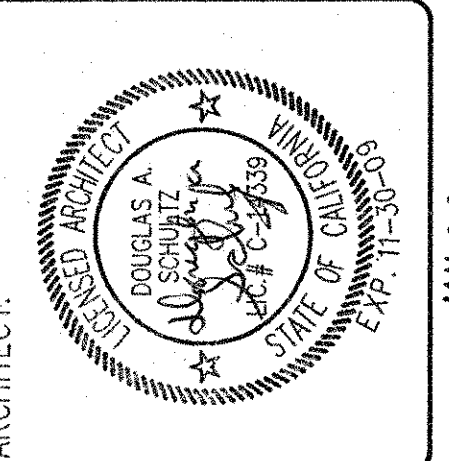
