Location

Droyslden is a town in Greater Manchester, 4.1 miles east of Manchester City Centre and 2.2 miles west of Ashton Under Lyme. The town has a population of 22,689 (2011 Census) whilst the borough of Tameside boasts a population of 214,000. The town is on the tram network providing easy access to Manchester and surrounding suburbs.


