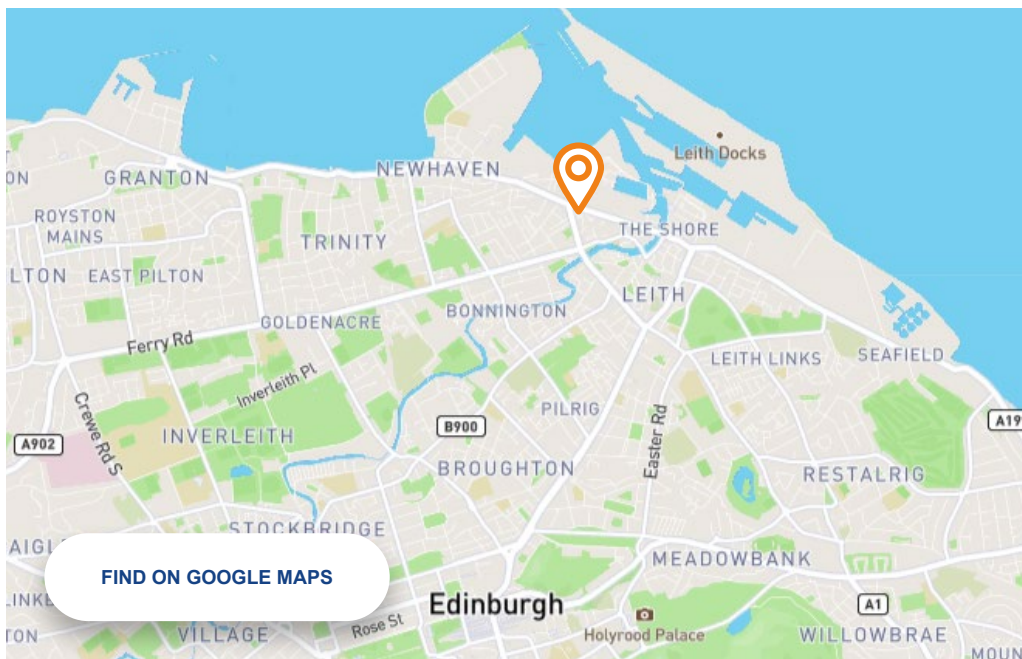

LOCATION

Ocean Drive is an area located in Leith, approximately 2.5 miles north-east of Edinburgh City Centre and is part of the Albert Docks 'Dockside' waterfront redevelopment. The subjects are situated in close proximity to Ocean Terminal, a large shopping and leisure complex which is due to undergo a substantial upgrade, and will enhance the area further.

The area offers a vibrant mix of amenities including restaurants, bars, shops and a cinema.

The location benefits from an excellent public transport network, with nearby Commercial Street, one of the main arterial routes from which bus access can be gained to all areas of the city. There is also a tram stop on the extended Edinburgh Trams route to Newhaven, which significantly improves access from Leith to Edinburgh's city centre.

DESCRIPTION

The premises comprises a ground floor retail unit of steel portal frame construction which benefits from the following specification:

- Concrete flooring
- Breeze Block Walls
- Steel portal frame
- Double-glazed commercial access window

Adjacent occupiers include Ocean Drive Dental Care, Kumon, Vitaliteeth Dental Spa, Ocean Orthodontic Clinic and Ocean Terminal Shopping Centre. Places of interest include the Royal Yacht Britannia which is berthed at Whisky Key.
