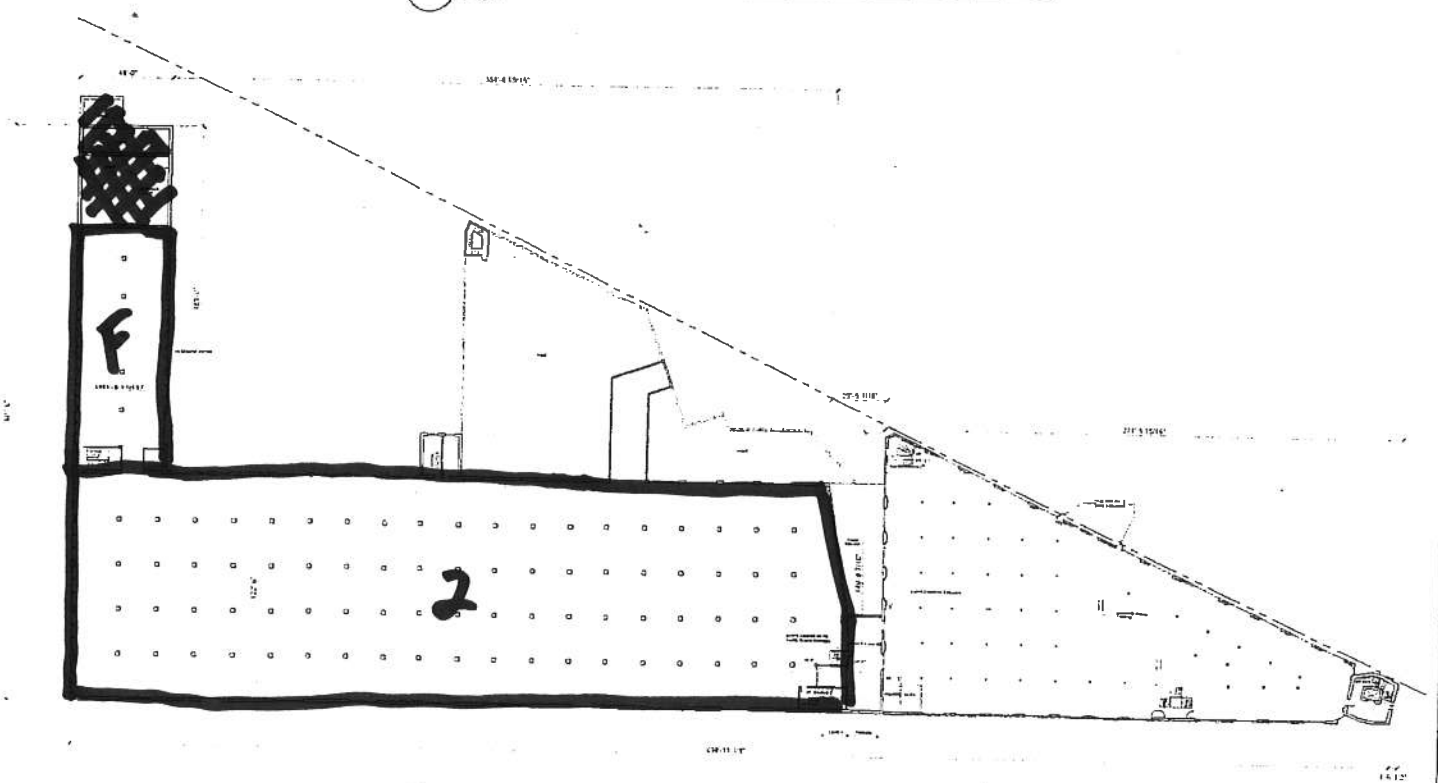


FIFTH FLOOR CONCRETE

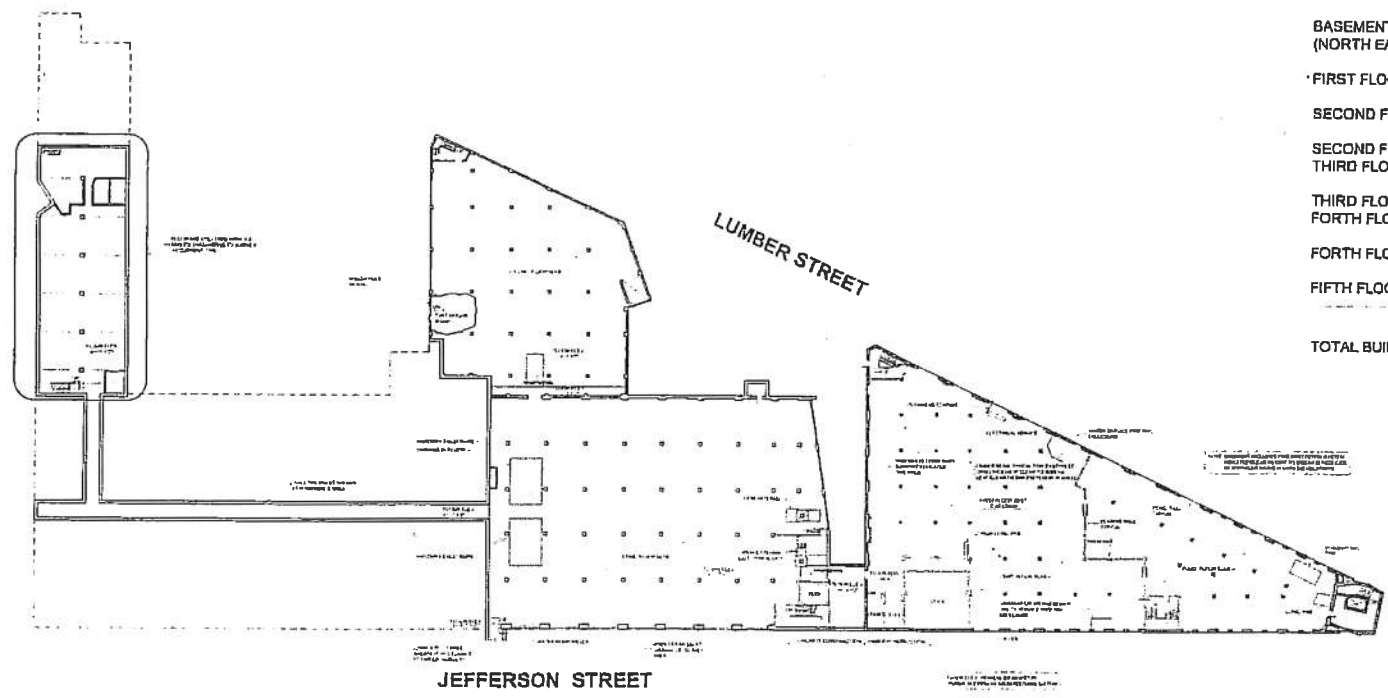
