LOCATION

Middlesbrough is a major north east conurbation situated 39 miles south of Newcastle and 10 miles east of Darlington. It is the principal shopping centre of Teesside (2011 Census Population in excess of 376,000).

Providing c. **400,000 sqft** of retailing, The Cleveland Centre is **Middlesbrough's largest shopping centre** and benefits from a dedicated **600 space car park**.

Major tenants include Boots, Costa, H&M, JD Sports, HMV, Topshop/Topman and WH Smith.

The subject property occupies a very prominent corner position on pedestrianised Linthorpe Road close to **McDonald's, Natwest** and **Lloyds Bank.** The second frontage to Newton Mall, where neighbouring occupiers include **Costa Coffee** and **Poundland,** could potentially provide **external seating**.


