LOCATION

DESCRIPTION


The subjects are within close proximity to Heathfield Retail Park, the principal retail park in Ayr and the wider South Ayrshire region.

The subjects comprise a prime development site at the junction of Wheatpark Place with Wheatpark Road, just north of Heathfield Road.
