#### Location

The premises are prominently positioned on the corner of Charles Street and Humberstone Gate, located within the heart of the city centre, directly opposite the prime pedestrianised shopping area of Humberstone Gate. The property is a 2-minute walk from the Highcross Shopping Centre and benefits from plenty of other nearby amenities. Leicester Railway Station is conveniently located approximately 5 minutes away.

#### **Description**

The subject property comprises the upper floor office accommodation of a three-story corner end of terraced building of brick construction beneath a flat roof. The external elevations have been fitted with UPVC double glazed windows.

The floor plates are broadly arranged in a similar format to provide generally open plan accommodation with some partitioned meetings room together with WC and kitchen facilities. The specification includes; a suspended ceiling with inset lighting, painted and plastered walls and carpet floor coverings. Heating/cooling is facilitated via a number of air conditioning cassette units. The suites have recently been repainted and recarpeted throughout.

The suites are accessed via a stairwell leading from the Charles Street frontage.

Our client would consider letting the premises on a floor by floor basis.
