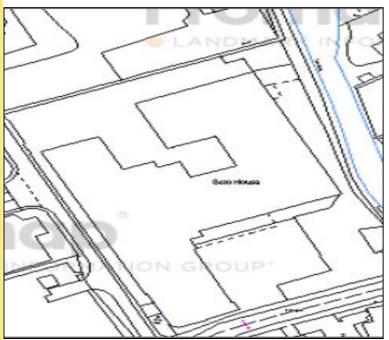

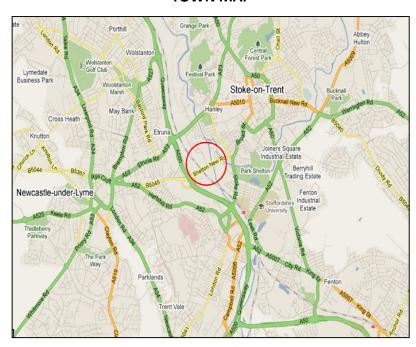
ORDNANCE MAP
