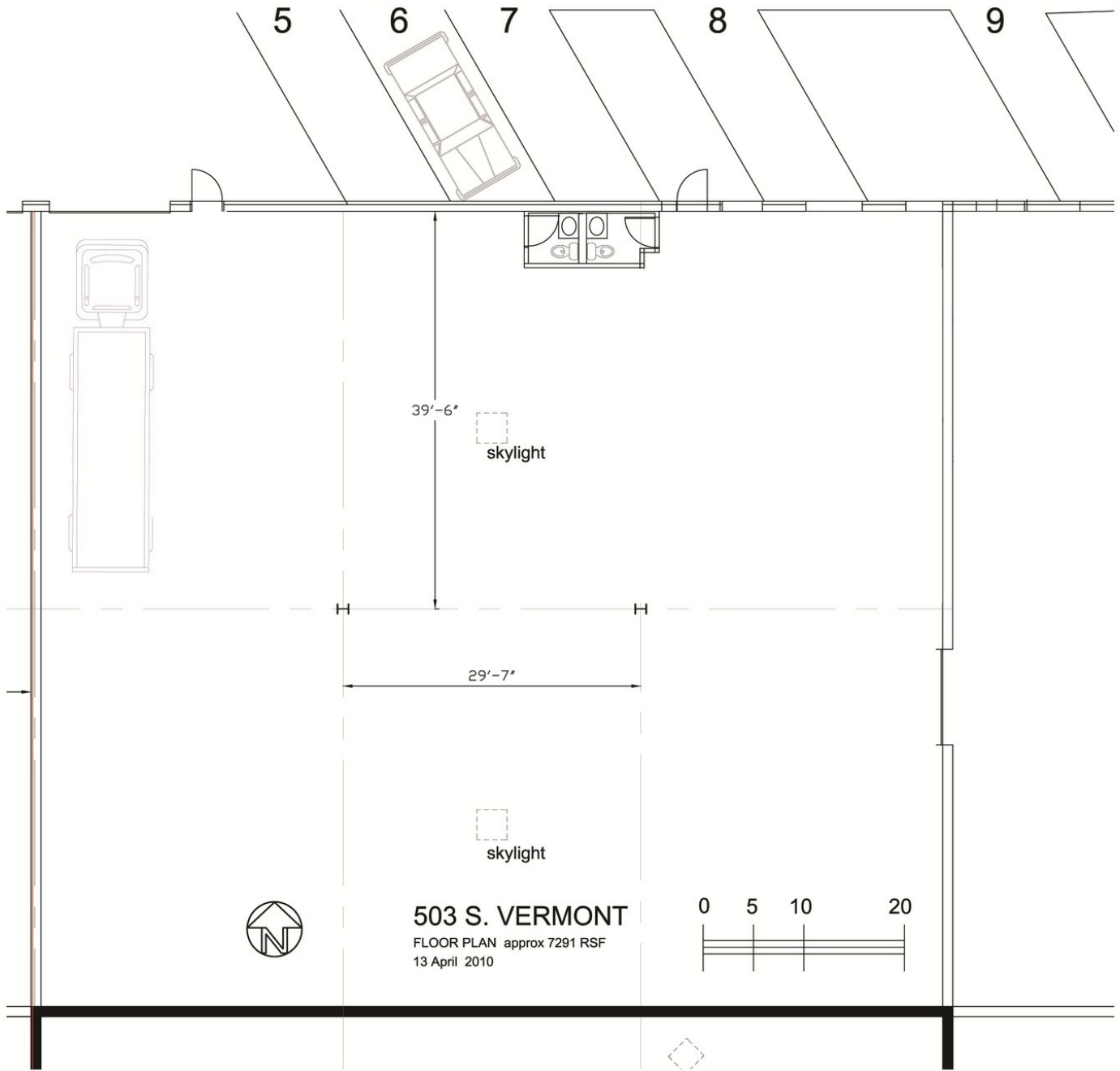

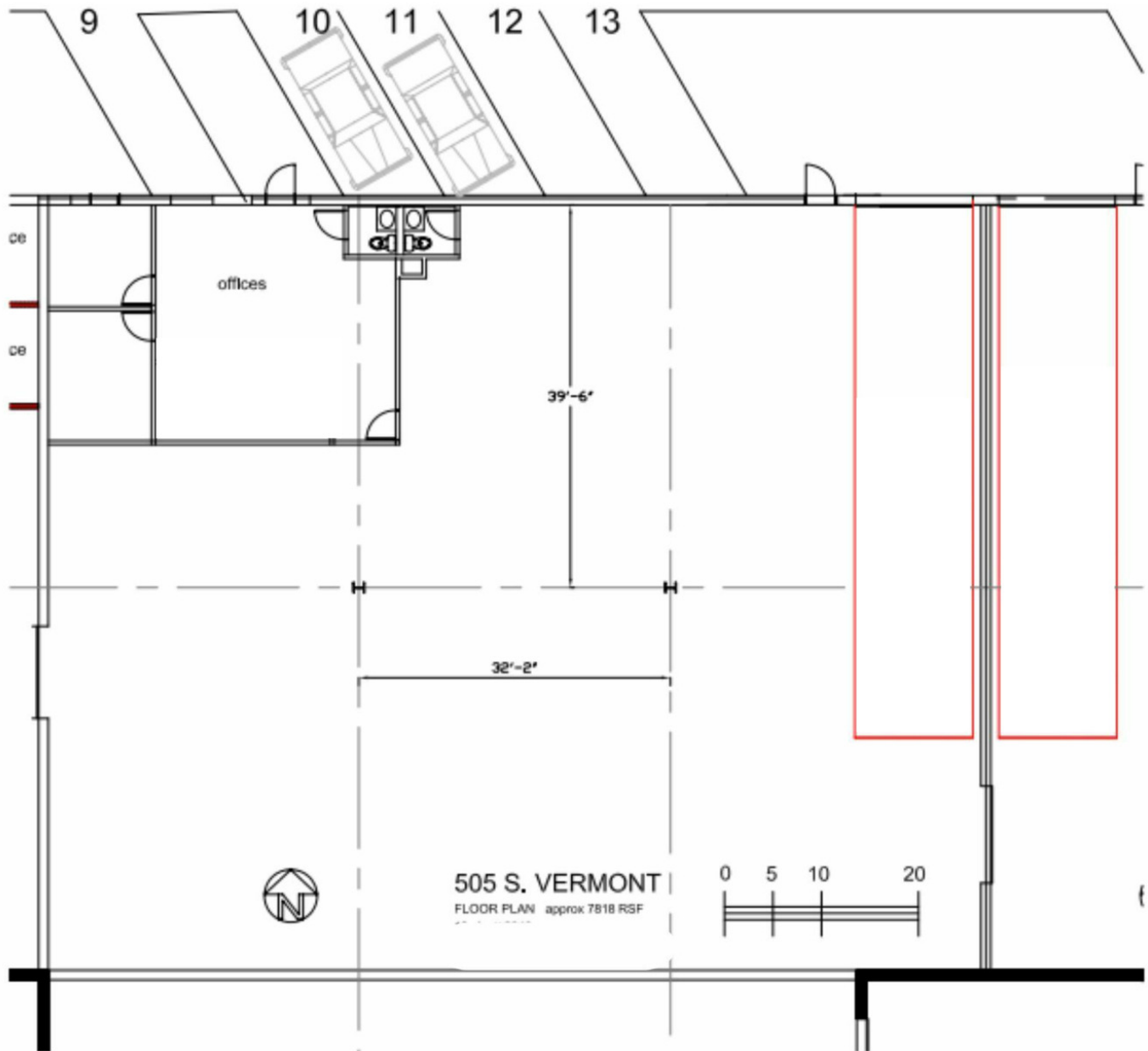
503 S VERMONT- FLOOR PLAN
