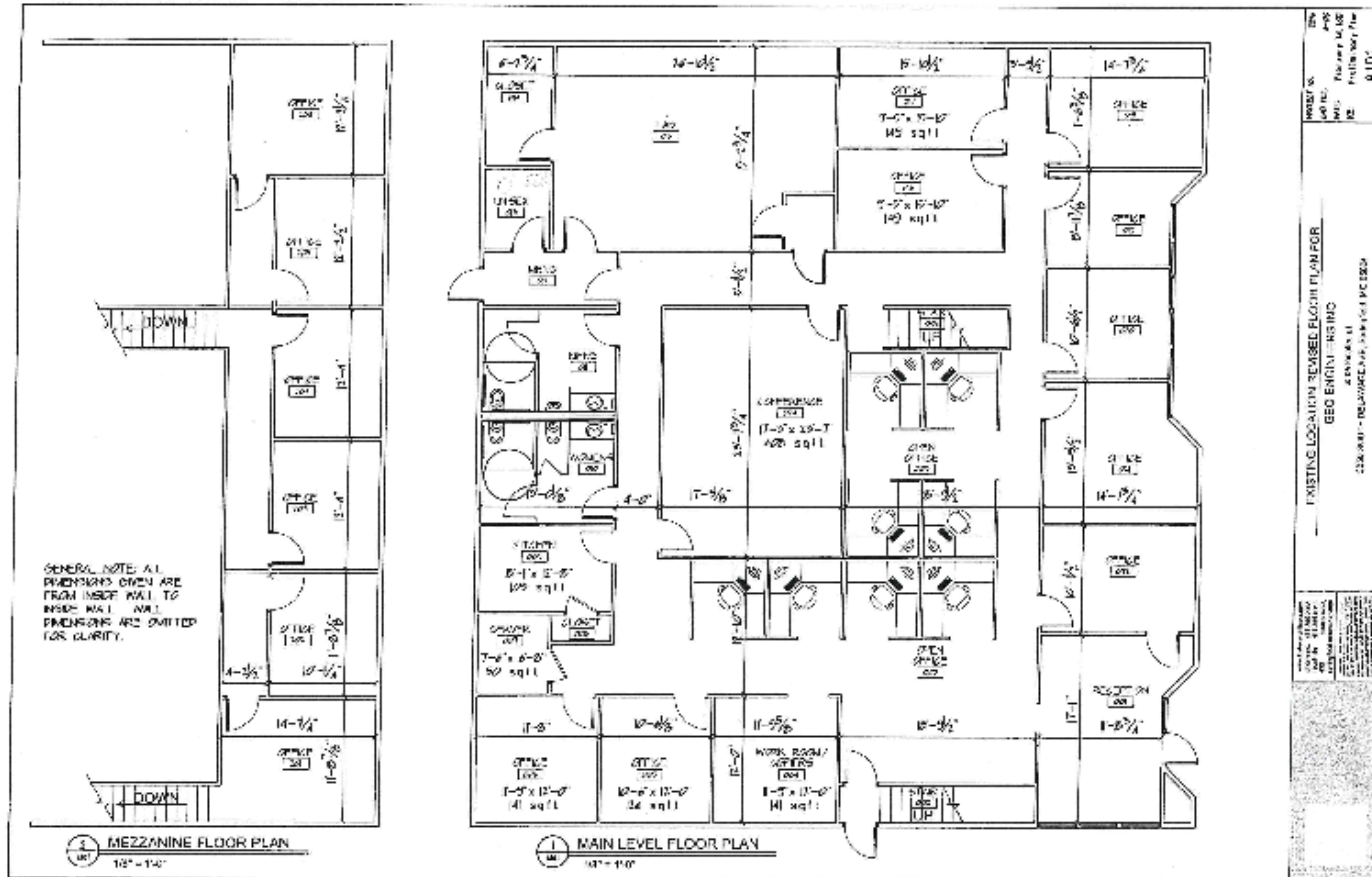

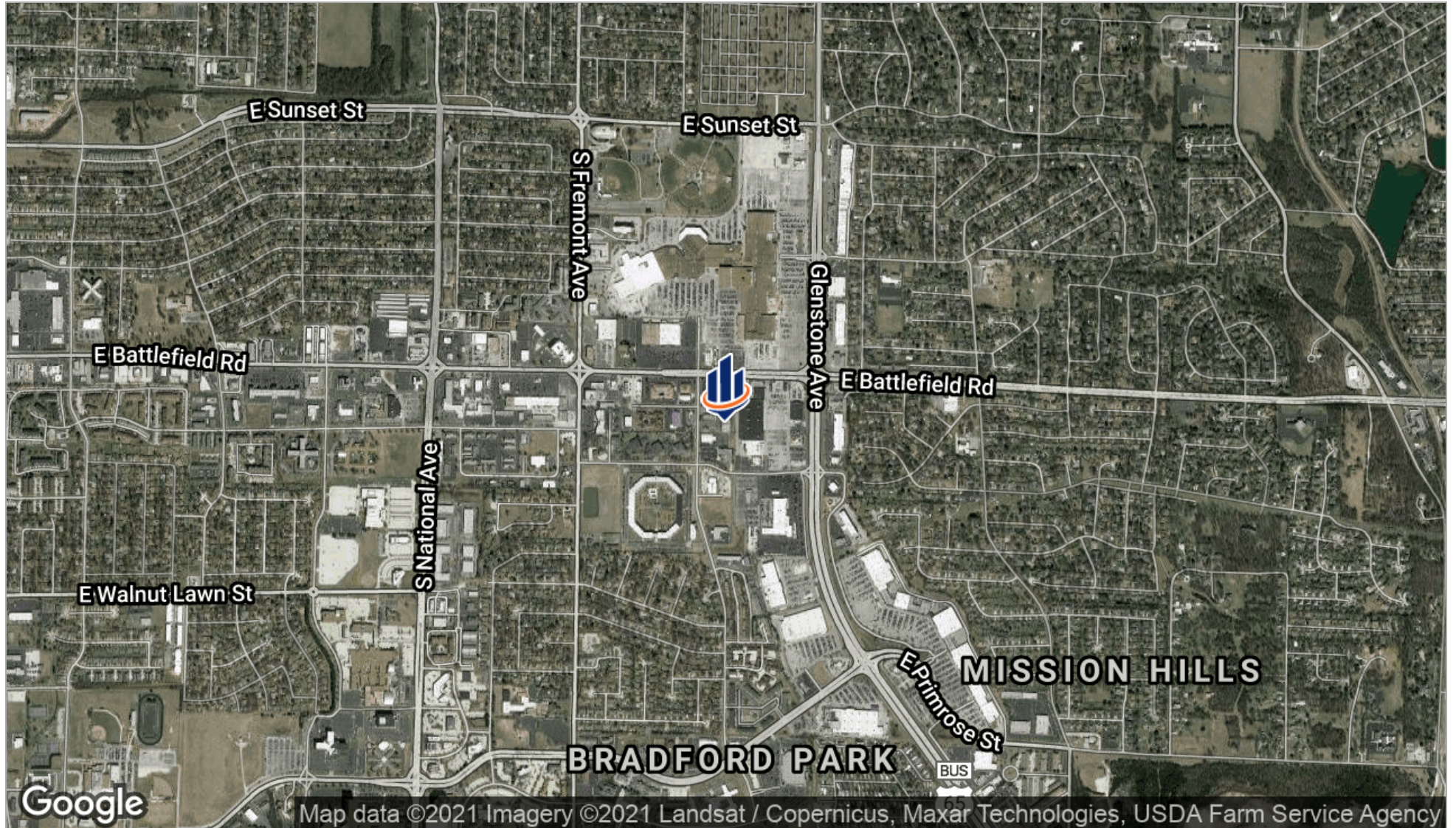

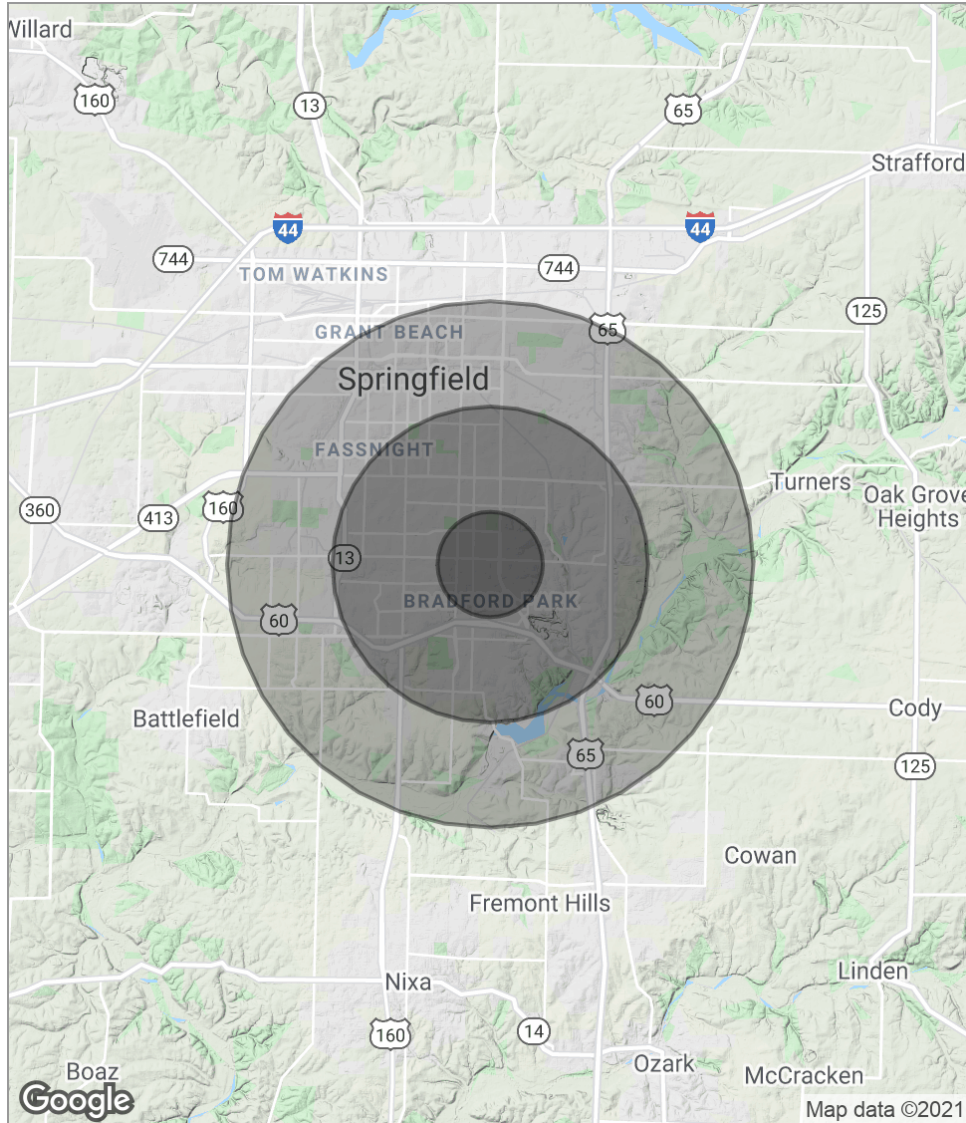
Suite 3050 Floor Plan
