## Location

Darlington is located in the North East of England and is a well known market town situated in County Durham. It has an urban population of circa 106,000 persons. Darlington is principally accessed by the A1/A19 and A66 Trunk Road.

The subject property, situated in Cockerton Green on the outskirts of Darlington, is well positioned within a local retail parade. The surrounding area has a mixture of both leisure and retail operators accommodating predominantly local operators.

## Description

The property comprises a ground floor lock-up shop, within a parade of units. The ground floor area offers a spacious retail sales area with ancillary storage and WC facilities. Other key specifications to the unit include ceiling fitted lights, electric wall mounted heaters and good levels of natural light projected via the glazed shop front. The unit comes with car parking to the rear of the unit. Other nearby occupiers in the area include; Coop, Heron, Greggs and William Hill.
