Location

The scheme is located on Old Grantham Road, on the edge of Whattonin-the-Vale village. This rural position provides quick access to the A52 Nottingham to Grantham road, a short distance from its junction with the newly dualled A46, which in turn provides access to both the M1 and A1.

Rent

Rent is payable quarterly in advance on the usual Quarter Days by Bankers Standing Order.


Service Charge


The service charge is inclusive within the rent.
