LOCATION

The subject property is situated with a frontage to Northern Road on the Northern Road Industrial Estate, in close proximity to its junction with the B6166, Lincoln Road, which in turn, travelling north and east links with the A46 and its connections with the A1.

The location is to the north and east of the centre of Newark, in an area of established industrial and commercial accommodation, close to Newark Northgate Station. Newark's position provides good access to the A1 and with the advance of rail transport, it is at the junction of the East Coast Mainline and the route from Nottingham to Lincoln.

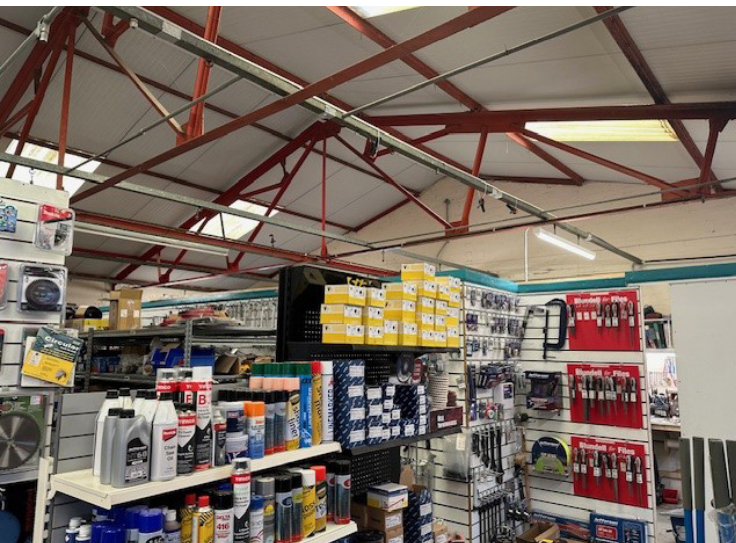
DESCRIPTION

The property comprises of a detached industrial warehouse of full height brick and block elevations, under a pitched roof situated prominently on Northern Road in Newark, Nottinghamshire.

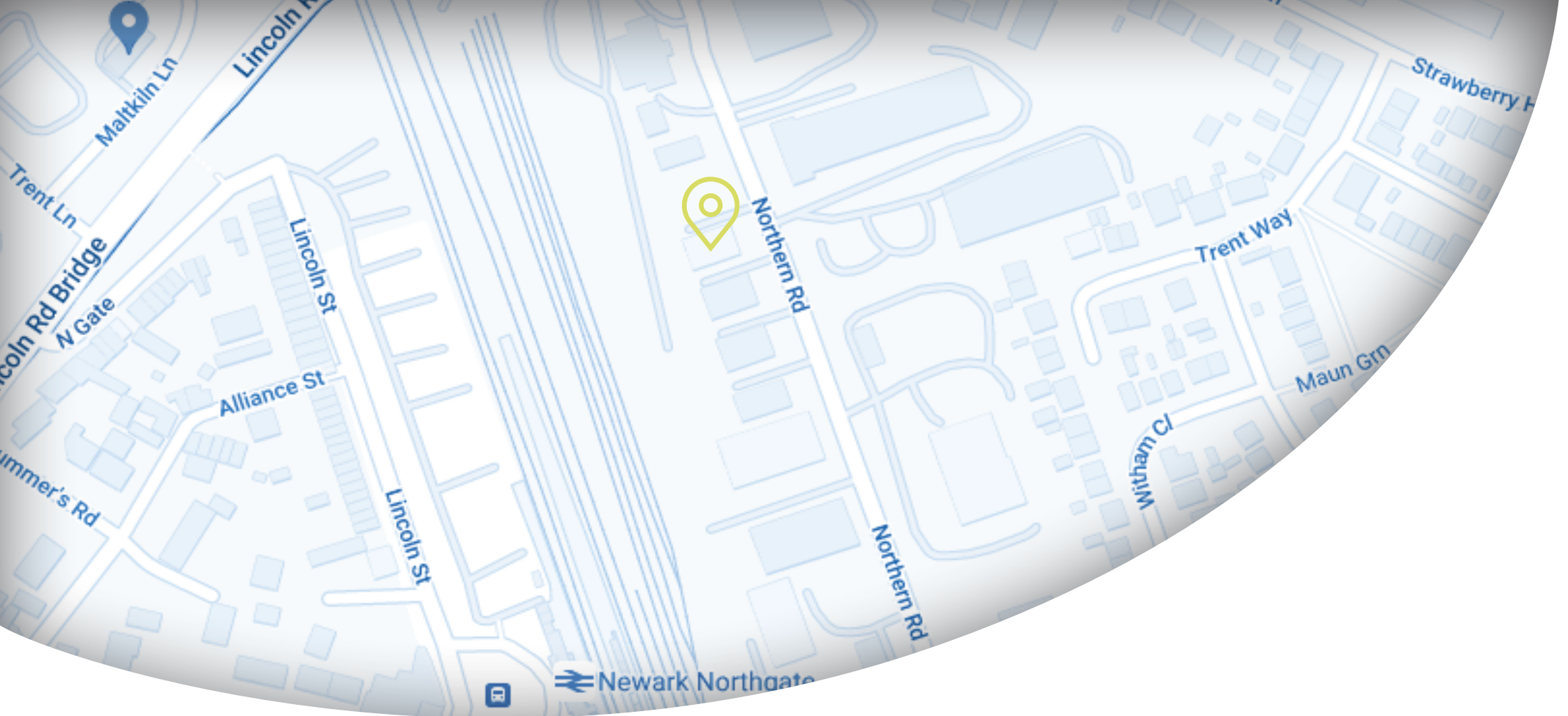
