Location

Altrincham is located 9 miles south west of Manchester City Centre and forms part of the wealthy South Manchester commuter belt. The town has one of the most affluent catchment populations in the UK.

ACORN Profile Affluent Achievers account for 49% of Altrincham's shoppers - over double the UK Average.

Stamford Quarter is the town's primary shopping area amounting to over 300,000 sq ft of modern retail and leisure accommodation. Occupiers include House of Fraser, Next, Debenhams, H&M, River Island, Waterstones, Paperchase, Le Bistrot Pierre and Nando's. Flannels.com are due to open a new store December 2017 immediately adjacent to the subject unit.
