LOCATION

The subjects are located within the small village settlement of Glenlomond approximately 650 m. to the north of Wester Balgeddie. This is a rural location comprising a small village with a range of housing styles.

The site itself is bound by residential properties and offers open views across the Loch Leven basin. The remainder of the site is bound by mature woodland.

DESCRIPTION

The site comprises a former nursing home which has now been demolished and benefits from full planning permission for the erection of 13 dwelling houses.

The site extends to 0.958 hectares (2.367 acres) or thereby and will be served by the existing access road which serves the village.


