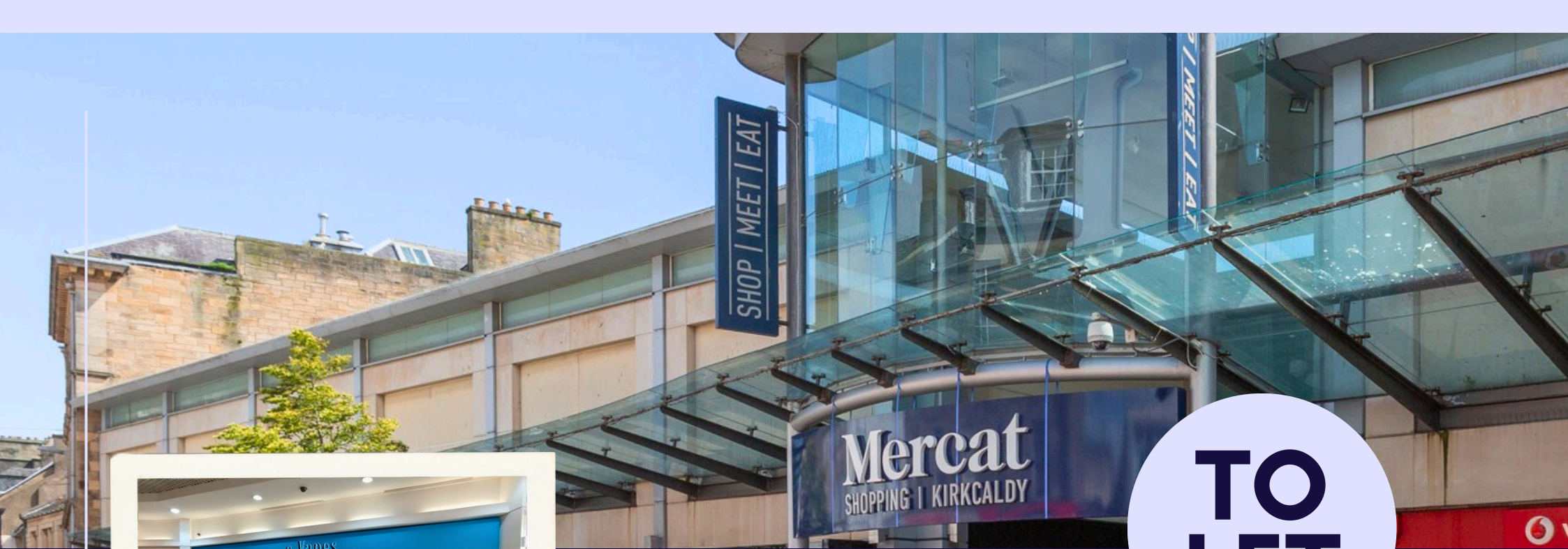

Additional funding has been allocated to enhance the High Street pedestrian zone and improve public spaces.

- ▶ Mercat Shopping Centre is a short walk from Kirkcaldy bus station.

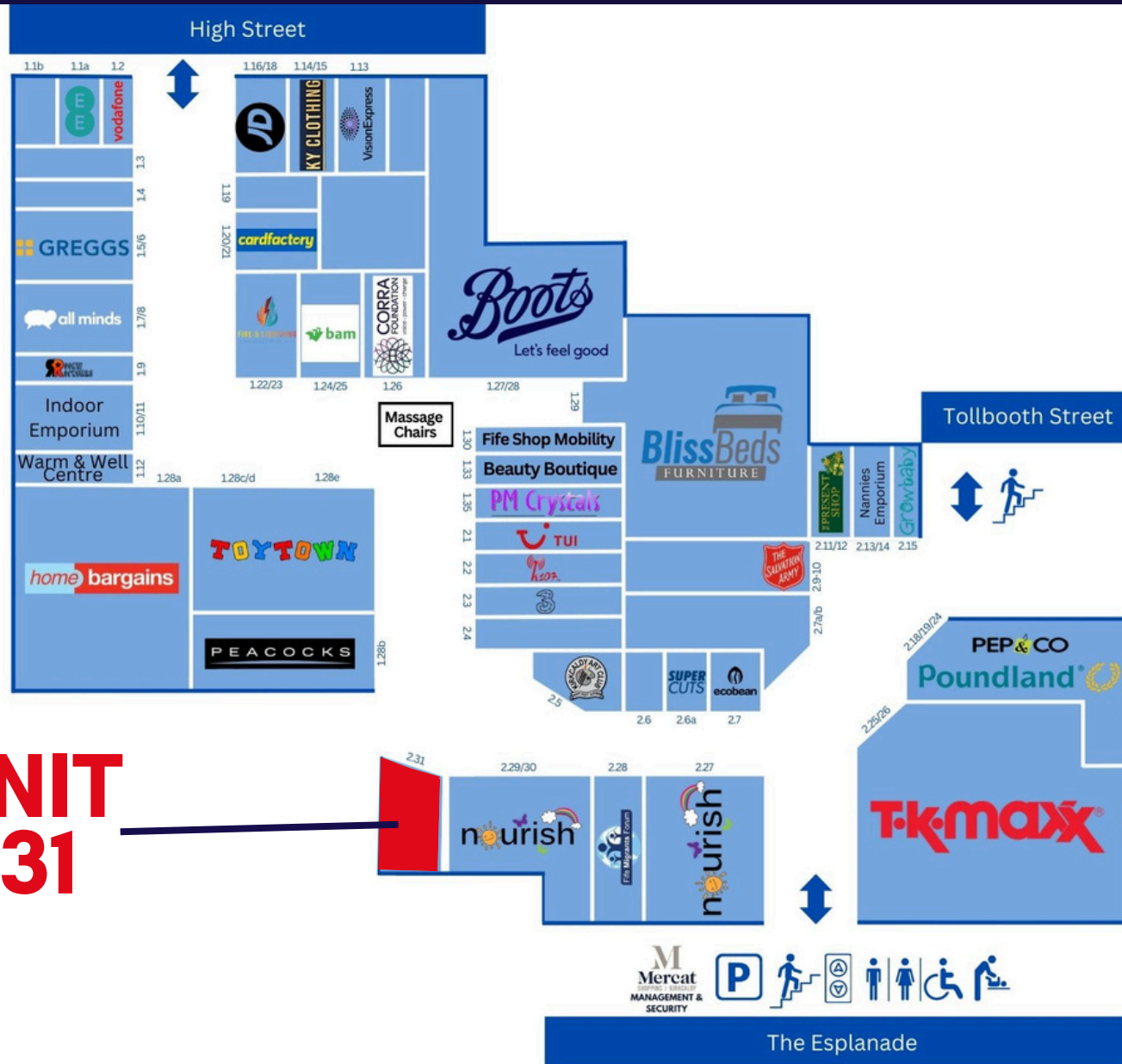
