Location

Hemel Hempstead is a well-connected commuter town of around 100,000 residents, situated just beyond the M25 with strong road and rail links into London. The town centre has seen substantial public and infrastructure investment in recent years, unlocking major redevelopment prospects.

Description

The Marlowes Shopping Centre provides over 340,000 sq ft of retail space in the centre of Hemel Hempstead. With 99 retail units, 1,200 parking spaces, and an average weekly footfall of approximately 125,000 visitors, the centre presents significant potential for retailers.

A deposit equivalent to 3 months rent plus VAT to be held by the Landlord for the duration of the lease.

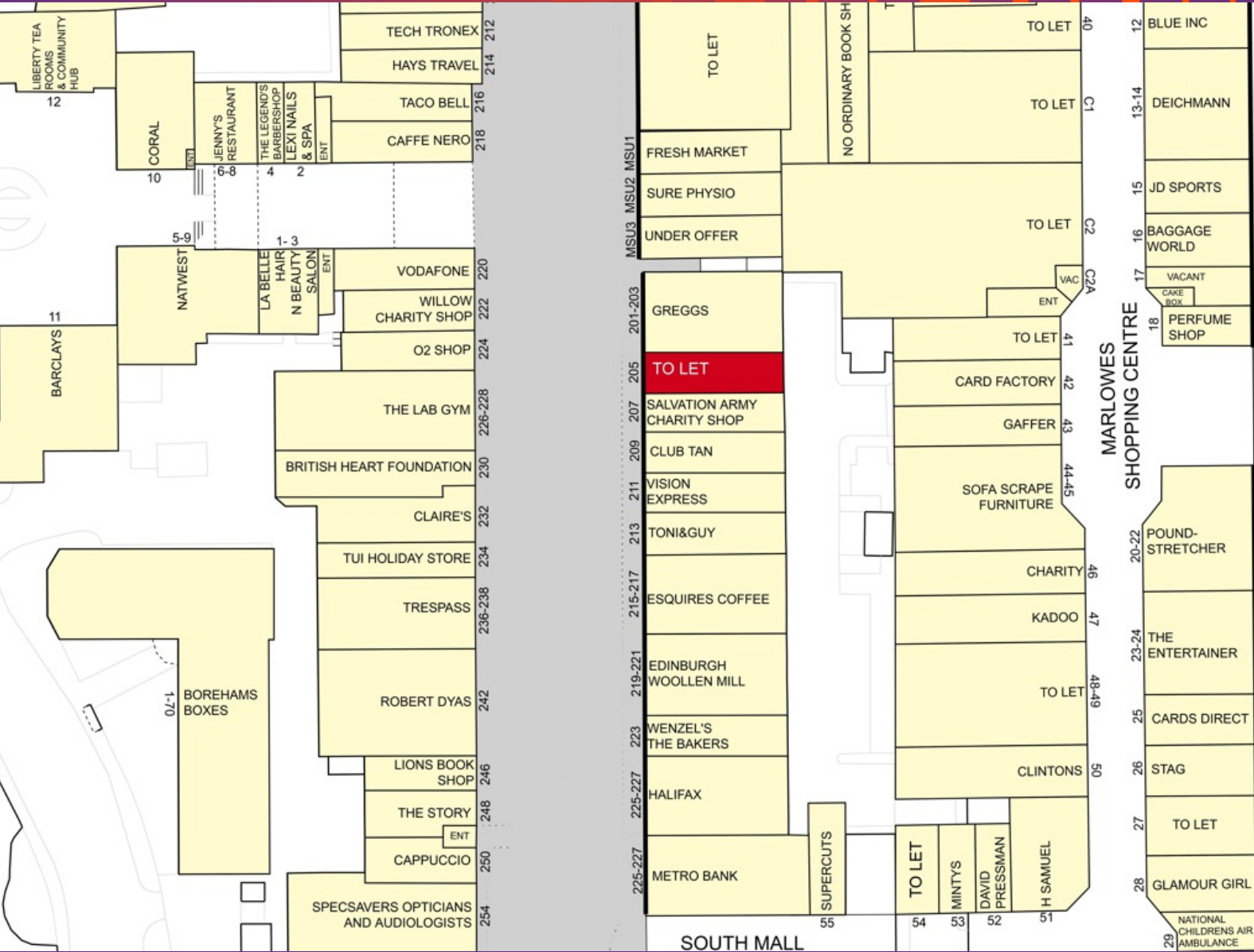
