## LOCATION

Fairfield Business Park is situated in close proximity to the A470 dual carriageway and is accessed via the Gwaelod-y-Garth junction for Taffs Well and Radyr.

Junction 32 of the M4 Motorway is approximately 1 mile away, with Cardiff City Centre approximately 7 miles to the south.

## DESCRIPTION

Faitfield Business Park provides a terrace of modern business units, of steel portal fame construction. Elevations are of cavity brickwork and blockwork to lower sections, with profiled steel cladding to upper elevations and the pitched roof, which includes translucent light panels.

Internally the unit offers open warehouse accommodation (minimum eaves height 6.1 m) with two storey office/ancillary accommodation to the front, including kitchen facilities.

The front elevation includes both vehicular and pedestrian access points with the shutter door measuring 5m (h) x 4m (w).

## **ACCOMMODATION**

Unit 3 has a gross internal area of 533 sq m (5,737 sq ft) including two storey office / ancillary accommodation of 106.7 sq m (1,149 sq ft)


