Location

Pride Park is located approx 1 mile from Derby City Centre and is generally regarded as a principle location for businesses.

The property benefits from excellent commuter and public transport links with Derby train station situated just 0.6 miles and Derby bus station 1.2 miles to the north west. The property has excellent access to the A38/A50 and the A52 which provides direct access to J25 of the M1 which lies just 7.0 miles to the east.

Description

The available office is situated on the first floor, above Handelsbanken and can be accessed via stairs or a lift. The office was constructed to open plan and has a separate office formed from demountable partitions. The accommodation has been finished to a high standard to include suspended ceilings, air conditioning, LED lighting and raised access floors with power and data.

There are shared male/female & disabled WCs and kitchenette.


