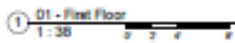

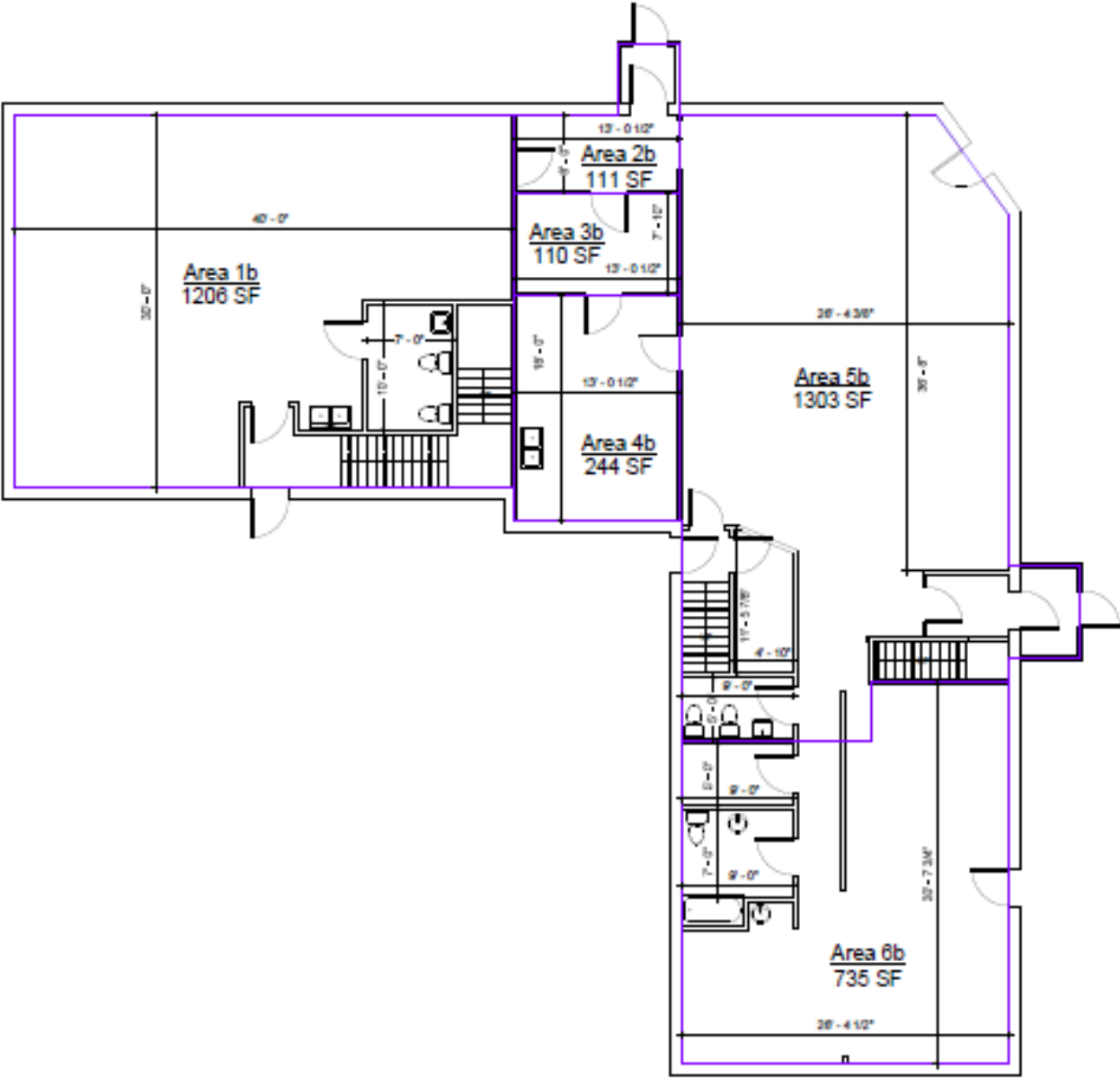

Floor Plans

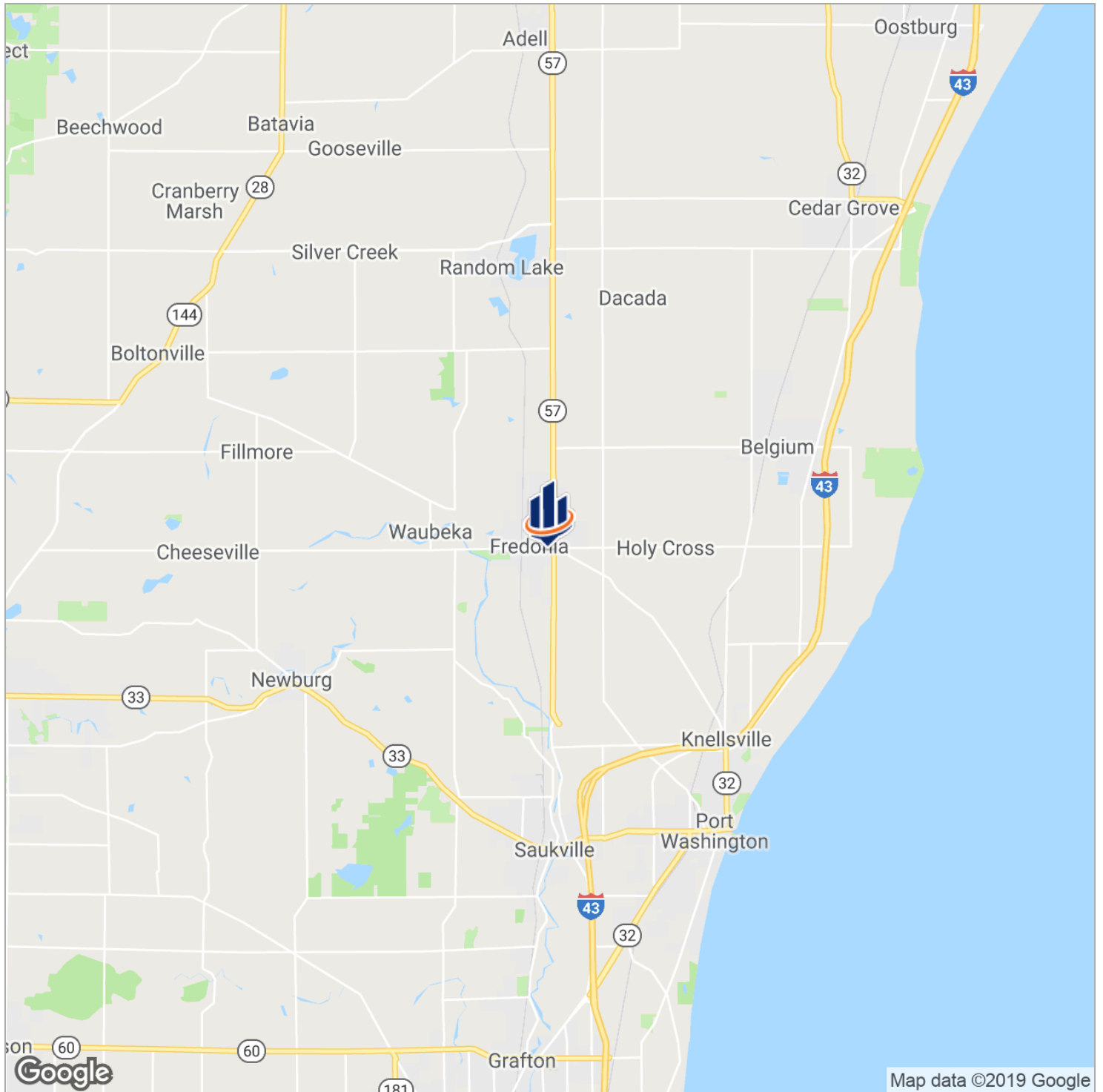

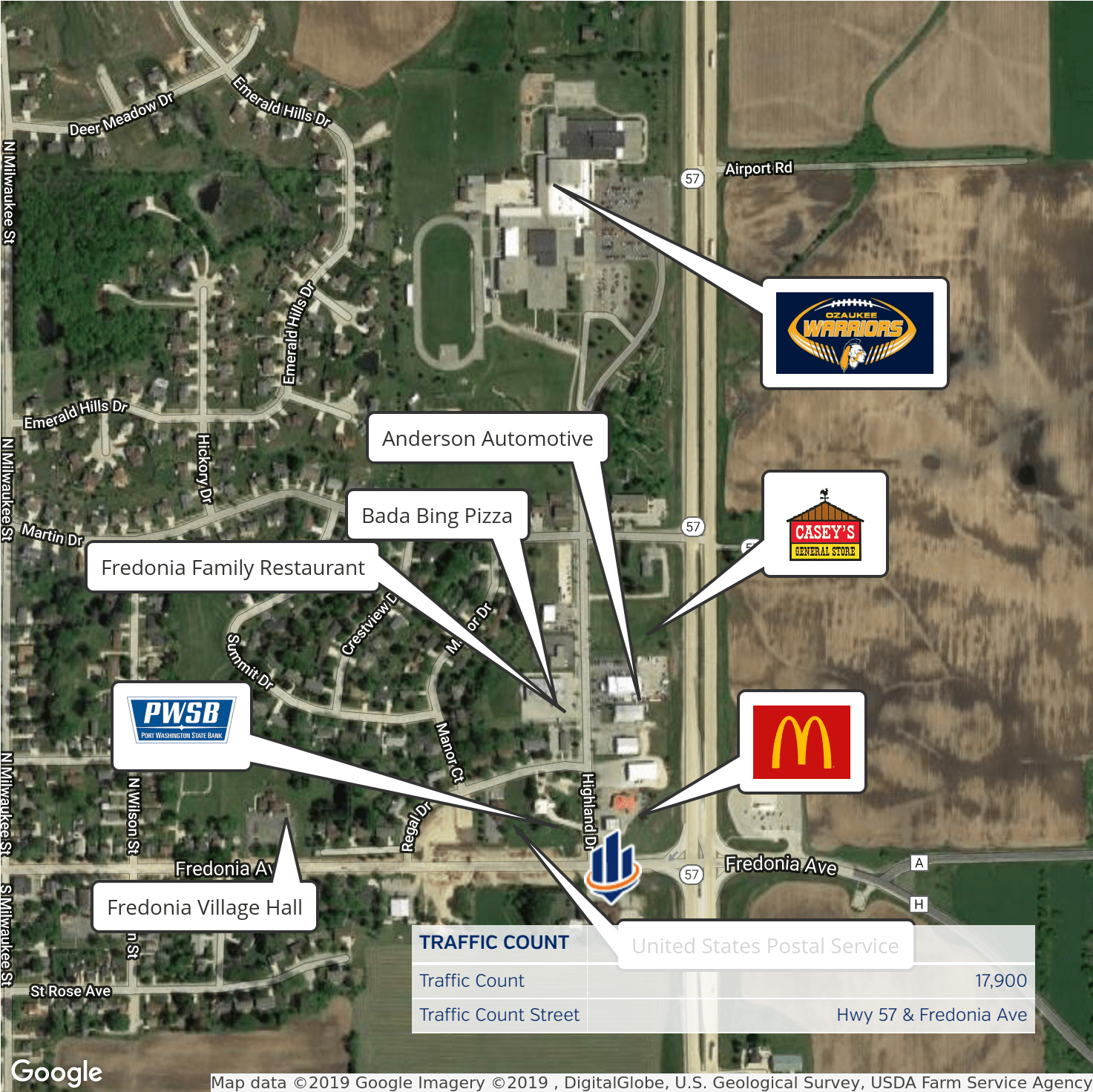
