

LOCATION

Norsea House is situated within a secure development located just off Crawpeel Road, Altens Industrial Estate. The location benefits from good access to the A956 Wellington Road and the wider trunk road network. Occupiers in the vicinity include Odjvell, Wetherford and Swire Oilfield Services.

DESCRIPTION

The available accommodation comprises surplus office space across ground and first floors within Norsea House, an office and industrial facility.
