# **LOCATION**

The subjects are located within Govanhill, an established pitch towards the south of the city centre. More specifically, the subjects occupy a position on the north side of Allison Street between Victoria Road to the West and Moreland Street to the East.

Surrounding buildings are of a similar tenement nature with ground floor retail units and residential flatted dwellings above. The area is diverse in nature and caters for the local population with many retailers providing European and international goods and commodities. Nearby occupiers include Paddy Power, Ladbrokes, Greggs and Boots.

## **DESCRIPTION**

The subjects comprise a ground floor retail unit which forms part of a larger 4-storey tenement of traditional blond sandstone. The retail unit has a traditional frontage with display window and a pedestrian access door secured by manual roller shutter.

Internally the property is fitted out as a hairdresser salon with a partitioned reception area to the front, open plan main salon and small staff area/WC to the rear.
