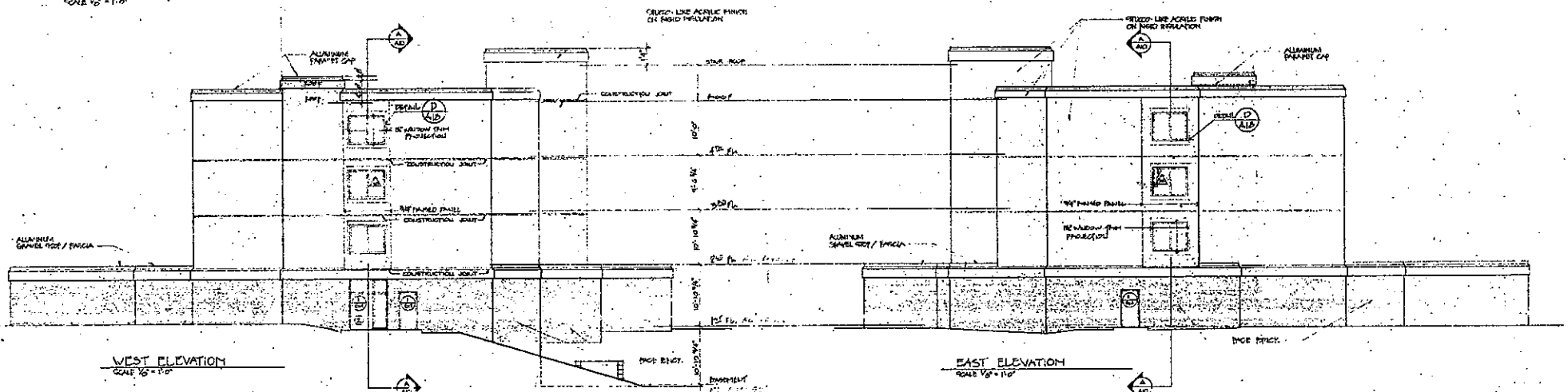


SOUTH ELEVATION (FRONT)
