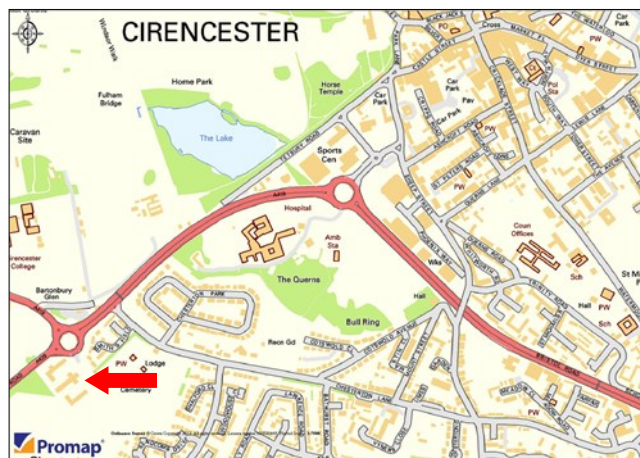

Location

Cirencester Office Park is a modern scheme of three significant office properties located approximately ½ mile to the north-west of Cirencester town centre fronting the A429 Tetbury Road.

Cirencester is situated equidistant between the M5 to the north and M4 to the south. Gloucester and Cheltenham are 12 miles to the north and Swindon is 14 miles to the south, accessed via the A417 / A419 which are in the main dual carriageways.

Kemble railway station is only 3 miles away and provides direct access to London Paddington in 75 minutes and Swindon or Cheltenham in 20 minutes.



Description

A three storey brick building built of Cotswold stone elevations under a pitched tiled roof. Unit 7 is situated on the ground floor.

The windows are double glazed with vertical blinds and there is a gas fired central heating system throughout. There are raised floors with carpets and suspended ceilings with Category 2 lighting.

There is a meeting room/executive office and the predominantly open plan offices also benefit from male, female and disabled w.c's with shower and kitchenette with built-in microwave and refrigerator.

There is a door entry control system.

Externally there are 5 car parking spaces.
