#### Location

Piccadilly is an important street linking the prime retail, leisure and office areas of the city centre with Manchester Piccadilly train station, which is a 5 minute walk away. Piccadilly Gardens opposite is the city's largest open space with lawns and seating areas which attract workers and visitors all year round. Piccadilly Gardens is a major transport hub with bus and Metrolink connections and it also boasts some of the highest footfall in Manchester city centre. According to the Manchester City Council website, the Gardens have a footfall of 90,500 on weekdays, 147,500 on a Saturday and 67,200 on Sundays.

The subject premises are situated on Piccadilly adjacent to Wetherspoons and directly opposite No.1 Piccadilly which is let to ASK Italian, Byron and Pizza Express. Debenhams, Primark, Starbucks, Tesco Express, McDonalds, Travelodge, M&S Food, Zizzi, Nando's and Morrisons are all represented fronting the Gardens.

The premises, which are Grade II Listed, are arranged over ground floor and basement.


