LOCATION

Sherborne is a highly attractive and well-preserved market town and is a popular retail and tourist destination located in north west Dorset. The town is famous for its medieval buildings, abbey and public school. and has an estimated population of approximately 10,000 which is increased significantly with the influx of tourists.

The premises are situated in a 100% prime location adjacent to **Crew** and **Vision Express** with neighbouring occupiers including **WHSmith**, **Boots**, **Fat Face**, **Mountain Warehouse**, **Costa Coffee**, **Joules** and **White Stuff**.


