### LOCATION

The subject property is situated on the edge of Port Talbot town centre and within close proximity of the M4 motorway.

The River Afan runs along the rear boundary of the property and the surrounding area is made up of predominantly residential properties.

#### **DESCRIPTION**

The property comprises a purpose-built church. The building is not listed. The church was built and opened circa. 1924. The construction comprises solid stone walls with side and rear elevations rendered, under a timber framed, slate covered pitched roof.

The accommodation briefly comprises an entrance vestibule, leading to the main hall, kitchen area, office/vestry and 2 WCs. Externally there is access a storage room, boiler room and WC.

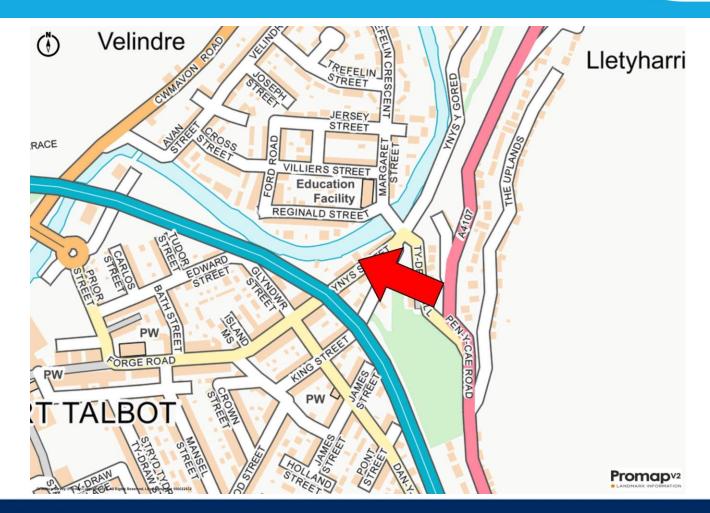
