## Location

The Peel Centre is located a short distance from Gloucester City Centre just off the A430 Bristol Road and directly opposite the Gloucester Quays Outlet and Leisure Development. Neighbouring traders include Gala Bingo Clubs, Toys R Us, Hobby Craft and Burger King. The free parking at the Peel Centre immediately outside the premises attracts significant numbers of cars in preference to the multi storey serving the adjacent Gloucester Quays Centre where charges apply.




