Location

The site is located on the Wilton International Complex to the east of Middlesbrough and accessed via either the A174 Parkway or the A66 from the A19, approximately 8 miles to the west. Teesport, one of the UK's largest deep-water port facilities, is approximately 4 miles to the north of the site.

The Wilton International Complex is a multi occupancy business and research centre, home to the Northeast of England Process Industry Cluster with occupiers such as Lotte Chemicals, Huntsman, Ensus and Semcorp operating from the site. www.wiltoninternational.co.uk

Description

The land comprises a cleared, serviced brownfield development site of level topography. Extensive infrastructure is already available on the Wilton complex including electricity, steam and water and this may offer cost savings to occupiers.

Area

The site in total extends to approximately 55 hectares (135 acres) but is capable of disposal in smaller lots.

Enterprise Zone Status

Wilton International has been designated as one of five Tees Valley Enterprise Zones. Qualifying occupiers within the target sectors of Chemicals and Renewable Energy may qualify for 100% capital allowances on capital investment.

Planning

We understand that the site is allocated as Employment Land, with the previous long standing use being B2 in nature.

As an Enterprise Zone, planning is through a Planning Performance Agreement (PPA) which can result in a streamlined planning process


