



LOCATION

The property is situated within the established Halesfield Industrial Estate, one of Telford's three main industrial locations. Telford Town Centre has seen a £250m development at Southwater over recent years and is approximately 4 miles to the north with Telford Central railway station being the same distance providing regular services to Shrewsbury, Wolverhampton, and Birmingham. Telford is located in the West Midlands and is approximately 15 miles east of Shrewsbury and 17 and 33 miles to the north west of Wolverhampton and Birmingham.

Major manufacturers in the town include GKN, Denso, Epson, Magna International, Magna Castngs, Makita, Ricoh UK and BAE Systems.
