# Location



The property is situated on Towngate Industrial Estate, a modern industrial development accessed from Ty Coch Way in close proximity to Cwmbran Town Centre. Road communications are via the A4042 roadway which gives access to the M4 and Newport to the south.

# Description

The property comprises a modern end terrace unit of steel portal frame construction with lower elevations of cavity brick / block work with insulated profile steel cladding to the upper elevations and translucent roof lights.

Internally, the unit has we connections and all mains services. The property has an insulated up and over access door.

Pedestrian access is gained via a double UPVc access door at the front of the building into the main production area which has a concrete floor.
