There is a 147 space car park accessible from Cross Street and Queen Street. Serviced by London Bus Route 99 - Erith Town Centre and Woolwich Shopping Centre. The Erith railway station, managed by South Eastern Trains, is only a short walk from the town centre. Peak service includes hourly trains from this station to London Charing Cross and London Cannon Street via Woolwich and Greenwich to the west. Peak service to the east includes hourly trains to Dartford and a limited service to Crayford or Gravesend and Gillingham.
