Location:

Workington is one of the main commercial centres in West Cumbria, being located approximately 35 miles south west of Carlisle and some 40 miles west of Junction 40 of the M6 Motorway at Penrith.

Flatts Estate is the principal industrial/trade counter location in Workington. Nearby occupiers include Screwfix, Jacobs Tool & Plant Hire, Eurocell, CEF, Greggs, and a range of local/ regional trade counter operators.

Description:

Unit 4A comprises a semi-detached single storey trade counter/ industrial unit of steel portal frame with cavity brick/ blockwork to approx. 2m and profile metal cladding above, under a mono-pitched roof with a clear eaves height of 3.85m rising to 5.15m.

The unit has been fitted out by the current tenant and incorporates trade counter, offices, ancillary accommodation together with ground and extensive mezzanine storage.

Vehicular access is provided via an electrically operated roller shutter door 3.6m (w) x 4.14m (h). Externally the unit benefits from 10 allocated vehicle parking spaces and shared circulation area.
