LOCATION

The premises are situated in a central position just south of Marks & Spencer's new food hall, within the semi-pedestrianised St John's Road shopping thoroughfare, being positioned close to major multiples such as Clarks, Holland & Barrett, Waterstones, Pret a Manger, Tiger of Copenhagen, Rush, etc. This location is a short distance from both the Clapham Junction main railway station and the extensive specialist shopping facilities along Northcote Road. 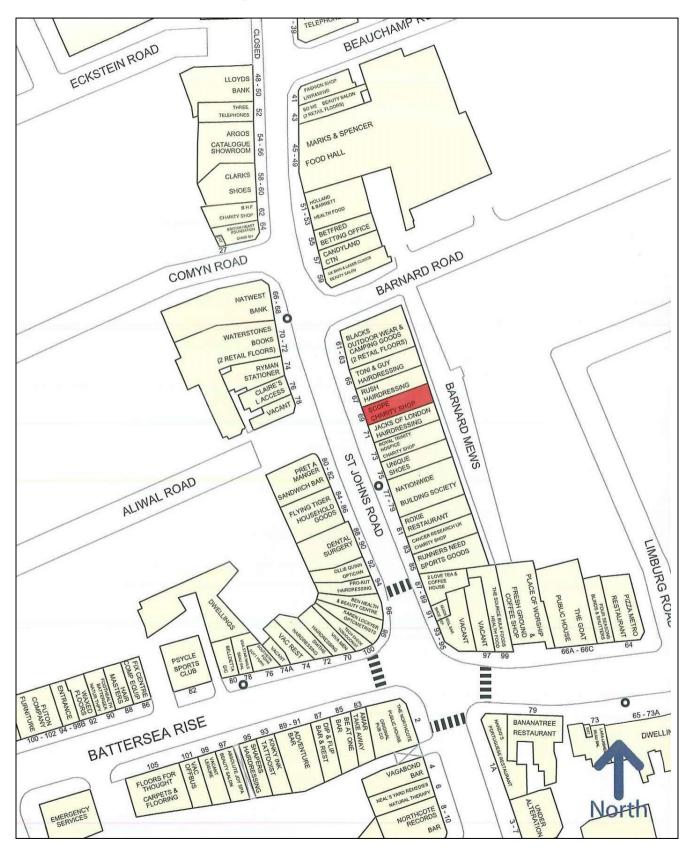
