Camarillo Business Center V is owned by the Menne Family, which purchased the building from its original developer in 2001. The Menne Family and its descendants have been based in Ventura County for five generations, initially engaged in agriculture but later diversifying into commercial real estate.

The Family's agricultural and commercial real estate is asset managed by Martin and John Menne. Martin Menne is President of MCM Diversified, which owns and manages office, retail, industrial and multi-family projects in the western US. He is responsible for the asset and property management of the Menne Family properties in that region. Prior to forming his company in 1994, Martin served for eight years as Director of Marketing and Asset Management for the Sammis Company, now known as Sares Regis Group. SRG was one of Ventura County's most prolific developers and owners of commercial real estate during the 1990's and 2000's. Martin is active in the local community and graduated in 1985 from USC's School of Policy, Planning and Development.

John Menne is responsible for the asset management of the Menne Family commercial real estate located in Southern California and Arizona, as well as managing the Family's agricultural investments. He retired from MetLife Real Estate Investors in 2013 as a Managing Director. He joined MetLife in 1985 and since 2001 served as head of the Los Angeles office, which is responsible for MetLife's commercial real estate investments in the southwest US totaling over \$7B. John has served in a variety of leadership positions including with the Mortgage Bankers Association and the Urban Land Institute. In addition, he is active with USC's Lusk Center for Real Estate, serving on its Board of Directors as well as serving as an adjunct professor. Within Ventura County, John is a member of the Board of Directors of Ventura Pacific Company, Pleasant Valley County Water District and Zone Mutual Water Company. John graduated in 1980 from UC Davis and received his MBA in Agribusiness from the University of Santa Clara in 1981.
