Location

Sinfin Commercial Business Park is positioned on Sinfin Lane to the south of Osmaston Park Road (Derby's outer ring road) approximately 2 miles south of Derby City Centre. The site has excellent transport links via the ring road to the A38, A50 and M1 motorway beyond.

Description

The property comprises two adjacent terraced units of a steel portal frame construction with brick/blockwork cavity elevations surmounted by profiled steel cladding to the upper elevations.

The units can be interlinked to provide a single warehouse, each bay benefiting from a meet and greet reception, tea point and WC. There are roller shutter doors to both units and 8 dedicated parking spaces.




