LOCATION

Ayr has a population of approximately 46,849 persons (Census 2011) and is situated 35 miles south west of Glasgow, 13 miles south of Irvine and 13 miles south west of Kilmarnock, connected by the A77/ M77 and A78 trunk roads. The subject property is prominently situated on the west side of Fort Street and the south side of Charlotte Street.

DESCRIPTION

The subjects comprise a ground floor office/ retail unit contained within a two storey end terrace building of solid stone construction under a pitched and slated roof, set back from the pavement line and has in more recent years been extended at ground floor level to both front elevations. This extension incorporates an extensive glazed frontage onto Fort Street and return glazed frontage onto Charlotte Street.

FLOOR AREAS

The Net Internal Area extends to 96.37 sq m (1,037 sq ft). All measurements have been carried out in accordance with the RICS Code of Measuring Practice (6th Edition).

RATEABLE VALUE

The subjects are entered in the current Valuation Roll with a Rateable Value of £10,600. The Uniform Business Rate for the financial year 201/ 2018 is 46.6p per pound of Rateable Value excluding water and sewerage charges.
