LOCATION

Peterborough is an historic cathedral city and unitary authority area in the east of England. It is the largest city in Cambridgeshire with a population of in excess of 190,000 and is currently one of the fastest growing cities in terms of population in the UK with a predicted population of 250,000 by 2022.

The property is situated in the established commercial of Woodston, close to the Nene Parkway, 1.5 miles to the south-west of Peterborough City Centre and 3 miles from the A1. Nearby occupiers include Woodham & Sturnham, Opals Group and Ray & Paul Interiors.

Facilities nearby include the Orton Hall Hotel, Nene Country Park and local shops.

DESCRIPTION

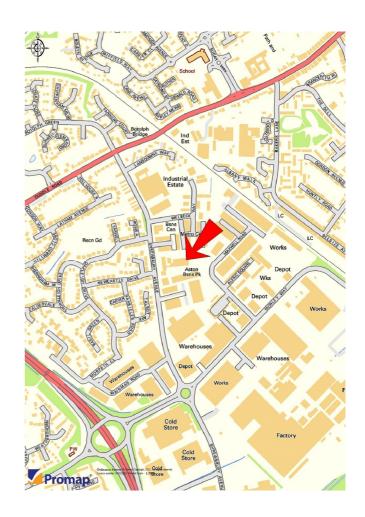
