DESCRIPTION

29 Lees Road comprises a substantial detached warehouse building with secure service yard upon a site extending to circa 3.03 acres.

The entire building and service areas have recently undergone a complete, extensive refurbishment, both externally & internally.

The building is constructed with brick built elevations under a steel framed roof structure, finished with profile steel cladding which has recently been replaced along with the roof containing excellent levels of natural light from the plentiful rooflights.

The building is finished to a very high standard with both dock and level access loading doors, offices/showroom, amenity areas, concrete yards, dedicated substation, canopy loading area and car parking.

LOCATION

The property is situated at the intersection of Lees Road and Kirkby Bank Road, in the heart of Knowsley Industrial Park which is one of the largest ind areas in the north of England.

Knowsley Industrial Park is located approximately 8 miles north east of Liverpool city centre and provides easy access to the port of Liverpool as well as the regional motorway network. The East Lancashire Road (A580) and the M57 are approximately 0.5 miles south and south east respectively.

Other major occupiers in the areas include QVC, Home Bargains, Matalan, Premier Foods/Kammac, Burtons Foods/DHL, News International and SIG.

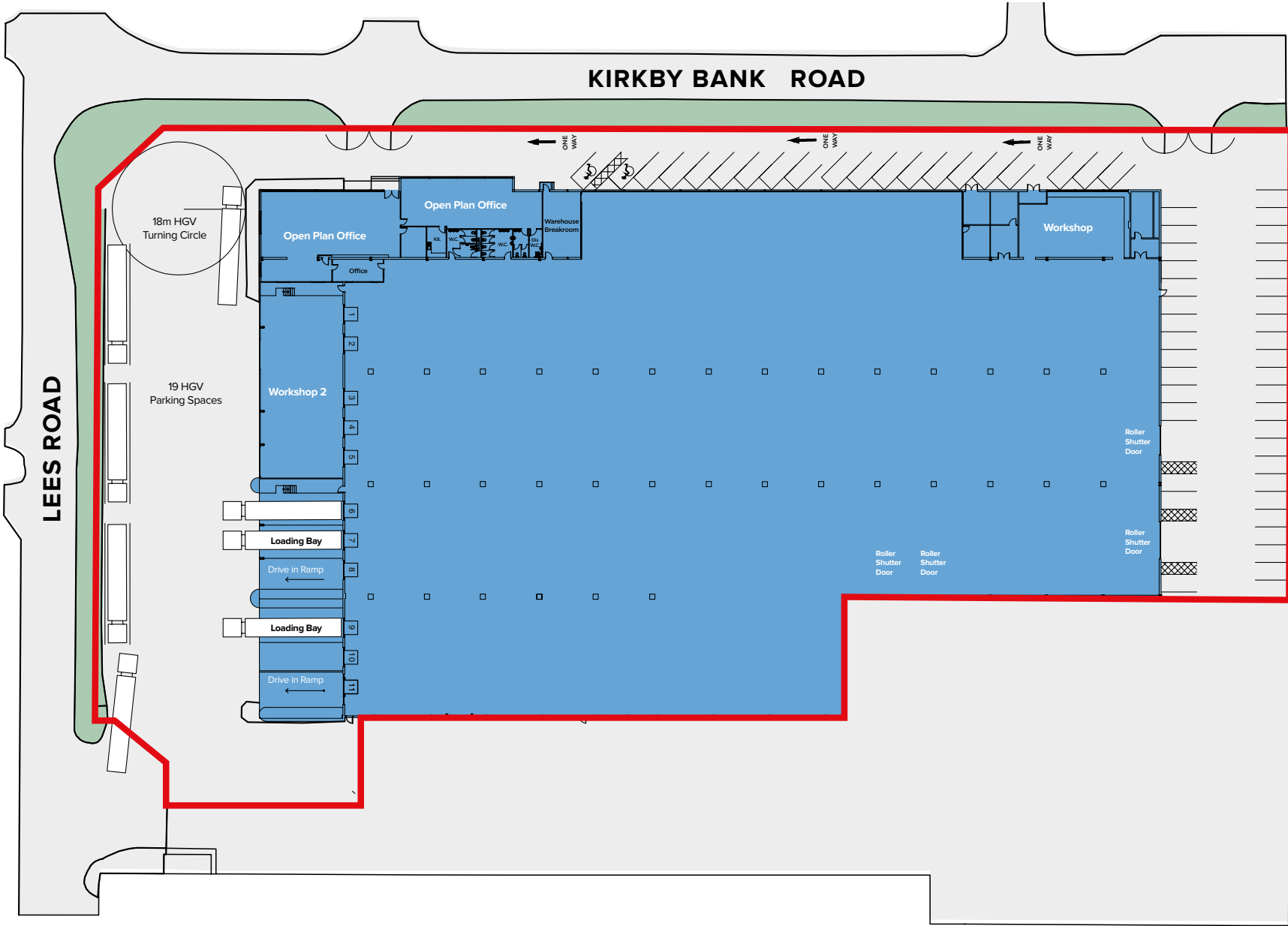
