



Location

Haudagain Retail Park is situated in a highly prominent location close to the well-known Haudagain Roundabout, a junction off the A90 and A96 trunk roads. The park comprises 4 modern detached retail units. Other occupiers within the development include Carphone Warehouse, American Golf and KFC.

Description

The subjects comprise a single storey retail warehouse of block construction under a pitched and tiled roof. The property benefits from extensive frontage and free customer parking. Internally the subjects comprise an open plan sales area with staff facilities. The internal fit out is of a good quality with fresh decoration and suspended ceiling.
